Data Files Collected by the HPD System

- Member Eligibility File
 - Member Identifiers, Age, Gender, Location
 - Payer/Health Plan Information, Assigned Primary Care Provider (PCP), Provider File
 - Provider Identifiers, Taxonomy/Specialty, Location.
- Provider File
 - Provider Identifiers, Taxonomy/Specialty, Location, Billing or Servicing.
- Medical Claims & Encounters
 - Primary and specialty care, outpatient surgeries, inpatient stays, laboratory testing
 - Home health care & nursing home care
 - Diagnoses, procedures, charged amount, paid amounts (plan and consumer paid amounts).
- Pharmacy Claims
 - Drug name, National Drug Code (NDC), quantity dispensed, charged amount, paid amounts (plan and consumer paid amounts)
 - Provider and Pharmacy information - name, specialty, location, mail order indicator.

Member Eligibility File Data Elements

- Subscriber/Member Information
 - Name, Street Address, Zip (*PHI*)
 - Social Security Number (*PHI*)
 - Date of Birth, Service (*PHI*)
 - Gender, Race, Ethnicity
 - Member Subscriber Relationship
 - Plan-specific Subscriber/Member ID or control number (*PHI*)
 - Primary Care Provider (PCP) - if assigned
- Payer Information
 - Submitter/Payer Codes, e.g., NAIC, HCAI/HPD assigned
 - Insurance Plan/Product Type, Category Code, Policy Number
 - Period of Coverage
 - Medicaid Eligibility Group & Aid Category
 - Medicare Eligibility Code

Provider File Data Elements

- Provider Information
 - Name, Street Address, Zip Code
 - National Provider Identifier (NPI)
 - Payer Assigned Identifier
 - Specialty/Taxonomy Code(s)
 - Provider License Number
 - Provider Tax ID
 - Group NPI
 - Affiliations/Network Relationships

Medical Claims and Encounter File Data Elements

- Bill Type, Place of Service
- Claims status, control number
- Payer Information (*EFI*)
- Provider Information - Billing & Servicing/Rendering Provider (*EFI*)
- Facility Information - for Institutional Claims (*EFI*)
- Patient Identifiers and demographics (*PHI*)
- Dates of Service (*PHI*)
- Diagnosis Codes, Modifiers, Principal/Other, e.g., ICD-10
- Procedure Codes, Modifiers, Primary/Other, e.g., CPT
- Payment Information (*EFI*)
 - Charged amount
 - Plan paid amount
 - Patient responsibility including coinsurance, copay, deductible

Pharmacy Claims File Data Elements

- Payer Information (*EFI*)
- Prescribing Provider Information (*EFI*)
- Provider Drug Enforcement Administration (DEA) Number (*EFI*)
- Patient Identifiers (*PHI*) and Demographics
- Date Filled (*PHI*)
- Drug Name
- National Drug Code (NDC)
- Payment Information (*EFI*)
 - Charged Amount
 - Plan Paid Amount
 - Patient responsibility including coinsurance, copay and deductible

Additional Information

- HCAI can provide additional documents describing HPD files and specific data elements in more detail.
 - All-Payer Claims Database – Common Data Layout (APCD-CDL)
 - Detailed descriptions of individual data elements by file type
 - The APCD-CDL is the data submission standard adopted by HCAI.
 - HPD Data Submission Guide (DSG)
 - Describes the requirements with which HPD data submitters must comply
 - Establishes additional, HPD-specific requirements not included in the APCD-CDL.
 - HPD Reporting Manual
 - A companion document to HPD regulations, APCD-CDL, and DSG
 - Provides discussion and comments related to the implementation of regulations.
