SEISMIC COMPLIANCE ATTESTATION

In accordance with California Nonprofit Corporation Law, the Board of Directors (the "Board") of Sutter Bay Hospitals, a California nonprofit public benefit corporation (the "Corporation"), hereby approves and adopts the following resolutions.

WHEREAS, California Health & Safety Code (the "Code") section 130065 requires all acute care inpatient hospitals buildings be in substantial compliance with the seismic safety regulations and standards developed by California Office of Statewide Health Planning and Development ("OSHPD") by January 1, 2030;

WHEREAS, section 130066 of the Code states that if any acute care inpatient hospital building is not currently in compliance with section 130065 of the Code, the Corporation must submit an attestation to OSHPD that the Board is aware the hospital building must meet the January 1, 2030, deadline for substantial compliance;

WHEREAS, the Corporation operates the acute care hospitals listed on Exhibit A; and


WHEREAS, some of the acute care hospital buildings are not yet compliant with section 130065 of the Code.

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Directors of Sutter Bay Hospitals hereby:

1. Acknowledges the Board is aware the acute care inpatient hospital buildings are required to meet the January 1, 2030, deadline for substantial compliance with California Health and Safety Code § 130065.
2. Authorizes, empowers and directs the authorized representatives of this Corporation, including officers and their designees, to file this resolution with OSHPD and to do and perform any and all such acts, including execution of any and all documents and the sending of any notices which are necessary to carry out the purposes and intent of the foregoing resolutions.

The resolutions above are adopted by the Sutter Bay Hospitals Board of Directors on November 20, 2019.
