RE: AB 2190 Attestation of Awareness

Dear Mr. Sheuerman,

Thank you for your letter regarding Assembly Bill 2190 (2018). It states:

‘Health & Safety Code, Section 130066: Before January 1, 2020, the owner of an acute care inpatient hospital whose building does not substantially comply with the seismic safety regulations or standards described in Section 130065 shall submit to the office an attestation that the board of directors of the hospital is aware that the hospital building is required to meet the January 1, 2030, deadline for substantial compliance with those regulations and standards.’


