

## Employer-Sponsored Health Care Coverage Reporting

Assembly Bill (AB) 1418 (Chapter 398, Statutes of 2025) expands the Department of Health Care Access and Information's (HCAi) existing Annual Utilization Report requirements for hospitals, long-term care facilities, primary care clinics, specialty clinics, home health agencies, and hospices. The bill broadens the scope of data that California health care facilities must report to HCAi, which HCAi subsequently publishes on its website to enhance public transparency.

AB 1418 increases HCAi's data-collection responsibilities by requiring annual reporting and public disclosure of employer-sponsored health coverage waiting periods. Licensed health facilities—including clinics, hospitals, long-term care facilities, home health agencies, and hospices—must report whether waiting periods for their employee health coverage exist and, if so, the length of those waiting periods. Facilities shall submit this information using standardized date ranges and, where applicable, be categorized by employee classification. These data will be critical for identifying disparities in health care coverage across California's health care workforce and support future policy efforts aimed at improving timely access to health coverage.

Beginning January 1, 2027, health facilities shall annually report employer-sponsored health coverage waiting periods to HCAi using forms provided by the HCAi, starting with data from calendar year 2026. Expanded Annual Utilization Reports are due **February 16, 2027**, for hospitals and long-term care facilities, and **March 15, 2027**, for primary care clinics, specialty clinics, home health agencies, and hospices.

The expanded reports for calendar year 2026 are due <b>February 16, 2027</b>, for Hospitals and Long-term Care Facilities, and <b>March 15, 2027</b>, for Primary Care Clinics, Specialty Clinics, Home Health Agencies, and Hospices.</li> <li>• Provide technical assistance to report submitters.</li> <li>• Review data for completeness and consistency.</li> <li>• Publish new and revised reports on the HCIA website.</li> <li>• Develop data products showcasing employer-sponsored health care coverage waiting periods.</li> </ul>
Ongoing	<ul style="list-style-type: none"> <li>• Continue to collect and publish reports based on the revised requirements.</li> <li>• Incorporate future validation upgrades or expansion based on stakeholder feedback.</li> </ul>
