#### Who are we? And what do we do?

HCAI - Department of Health Care Access and Information

Office of Statewide Hospital Planning and Development Building Safety – HCAI

- 1. Promulgate regulations in Title 24 for Hospitals, Skilled Nursing Facilities, Acute Psychiatric Hospitals
- 2. HCAI is the building department for these facilities
- 3. Promulgate OSHPD 3 CLINIC regulations in Title 24, Chapter 12, Section 1226
- 4. HCAI has authority to make or modify regulations (building standards) for health care facilities licensed by CDPH, including Alternative Birthing Clinics.
- 5. Coordinate with CDPH (licensing), CPCA, oSFM (Fire and Life Safety) and DSA (Access)

#### Purpose of the meeting

#### **BACKGROUND:**

Increasing concerns about access to birth services in California

And rural areas in California

Hospitals close labor and delivery services

 Since 2012, total of 56 hospitals (16% of CA hospitals) removed labor and delivery services

Challenges ABCs face seeking Title 24 compliance and CDPH licensure



## Types of birthing centers in CA

Birth Centers – Operate with valid professional license and business license

Birth Centers – Accredited by The Commission for the Accreditation of Birth Centers (CABC), to AABC standards. Accreditation is a voluntary process.

Alternative Birthing Clinics – Clinics licensed by CDPH and must comply with Title 24 OSHPD 3. ABC building regulations are in the California Building Code, Section 1226.11, and CEC, CMC & CPC.



#### What is OSHPD 3?

Title 24 contains the minimum building standards (regulations) for the construction and alteration of buildings and structures in CA. Title 24 is comprised of building, fire, electrical, mechanical, plumbing regulations, energy and sustainable, etc.

HCAI/OSHPD amend Title 24 (Section 1226.11 - [OSHPD 3] CLINICS) for ABCs listed in HSC 1204 (b)

CDPH responsible for licensing ABCs and they promulgate Title 22 regulations (points to Title 24 for building standards)

#### HCAI/OSHPD TIMELINE

- May 1 ABC public meeting
- June-August Prioritize and draft ABC code changes
- August email draft regulations to interested parties
- June-August Draft and publish ABC guidance documents
- October Complete 2025 Intervening code changes
- Dec. 2025 July 2026 Formal rulemaking process with CBSC
- July 2027 New regulations effective



#### ABC guidance document and Checklist

- The **guidance document** will assist design professionals, ABC owners/operators and the local jurisdictions on compliance with the current edition of Title 24.
- The checklist will provide a list of the applicable building code sections.
- Ready by June 30, 2025 (tentative)
