Update Section G. 2. on page 6 to read:

Applicants must submit a sustainability letter **from the sponsoring institution or organization** reflecting the number of students to be enrolled as a result of receiving grant funds. For Expansion Program applicants, the sustainability letter **from the sponsoring institution or organization** must indicate the number students to be added.

Amend Attachment D, Section C.1. on page 27 to read:

1. Under the direction of the Program Director, use Grant Funds to provide PMHNP training for [Number of Participants] student(s) for up to a four-year cycle beginning July 1, 2021, and ending June 30, 2025. Each student supported represents a permanent expansion of the program.

The Program Director shall also ensure the receipt of PMHNP program approval from a national accreditation body such as the Accreditation Commission for Education in Nursing (ACEN) or Commission on Collegiate Nursing Education (CCNE) and the California Board of Registered Nursing (BRN).

Amend Attachment D, Section F. on page 30 to read:

- F. Budget Detail and Payment Provisions:
 - 2. Payment Provisions
 - a. OSHPD will release twenty percent of the grant award each year over the grant period upon receipt of each annual Program Report. Section C. items 2. j. lists the Program Report due dates.
 - b. OSHPD will release the first payment installment upon receipt of:
 - I. A letter from a national accreditation body for a PMHNP program such as the Accreditation Commission for Education in Nursing (ACEN) or Commission on Collegiate Nursing Education (CCNE) verifying approval of the PMHNP program by July 1, 2021,
 - II. A letter or documentation from the California Board of Registered Nursing (BRN) signifying subsequent approval of the PMHNP program by July 1, 2021, and
 - III. A Program Report by July 31, 2021.
 - c. In the event that the grantee requests and OSHPD approves an extension of the due date for receipt of the letter of approval to establish of the PMHNP program from a national accreditation body and/or documentation the PMHNP program by the BRN, the first Program Report remains due on July 31, 2021.
