Funding Consideration: Quintiles

- Commission approved methodology.
- Seventeen programs qualified for funding by receiving at least 50 percent of total points (50).
- Provides funding to all 17 programs according to approved methodology.
- Program funding amounts:
 - Three programs in quintile one 100 percent of requested funding.
 - Six programs in quintiles two and three 75 percent of requested funding.
 - Eight programs in quintiles four and five 50 percent of requested funding.
- Total funding allocation: \$1,776,000 (\$80,244 left, converted to Data Fund rollover).

Definitions:

Family Nurse Practitioner: An advance practice registered nurse that has graduated from a family nurse practitioner training program and is certified as a nurse practitioner by the California Board of Registered Nursing. Physician Assistant: A physician assistant is a primary care practitioner who meets the Div. 2, Ch. 7.7, Section 3501 of Business and Professions Code requirements, and is licensed by the Physician Assistant Board.

Recommended Award Methodology: 50 percent minimum of total maximum points

1. Exclude programs with incomplete applications.

2. Assign average score for Sections 1.1, 1.2, 2.1, and 2.3 to programs with no data available.

3. Arrange Total Score from highest to lowest score.

4. Award zero slots to programs with less than 50 percent of total maximum points.

5. Divide remaining number of applicants by five.

6. Award top quintile maximum award based on program size.

7. Award second and third quintiles 75 percent of maximum award based on program size.

8. Award remaining programs 50 percent of maximum award based on program size until funds are exhausted.

9. Round up half slots.

10. Commission adjusted quintiles to develop finalized award recommendations.
