Allowable Use of Data Fund*

- \$6,656,000 annual appropriation from Data Fund.
 - \$2,725,000 dedicated to Registered Nursing (RN).
 - \$3,931,000 flexible funding for RN, PCR, and FNP/PA.
 - The Commission adopted a funding split for the flexible funding of :
 - PCR—\$2,581,000 or (66% of Data Fund)
 - FNP/PA—\$1,350,000 or (34% of Data Fund)
 - Commission has diverged from these splits.
- The Commission has authority to allocate the flexible portion of the Data Fund:
 - Maintain or change current split between FNP/PA and PCR while retaining flexibility.
 - Remove designated funding split and maintain flexibility.
