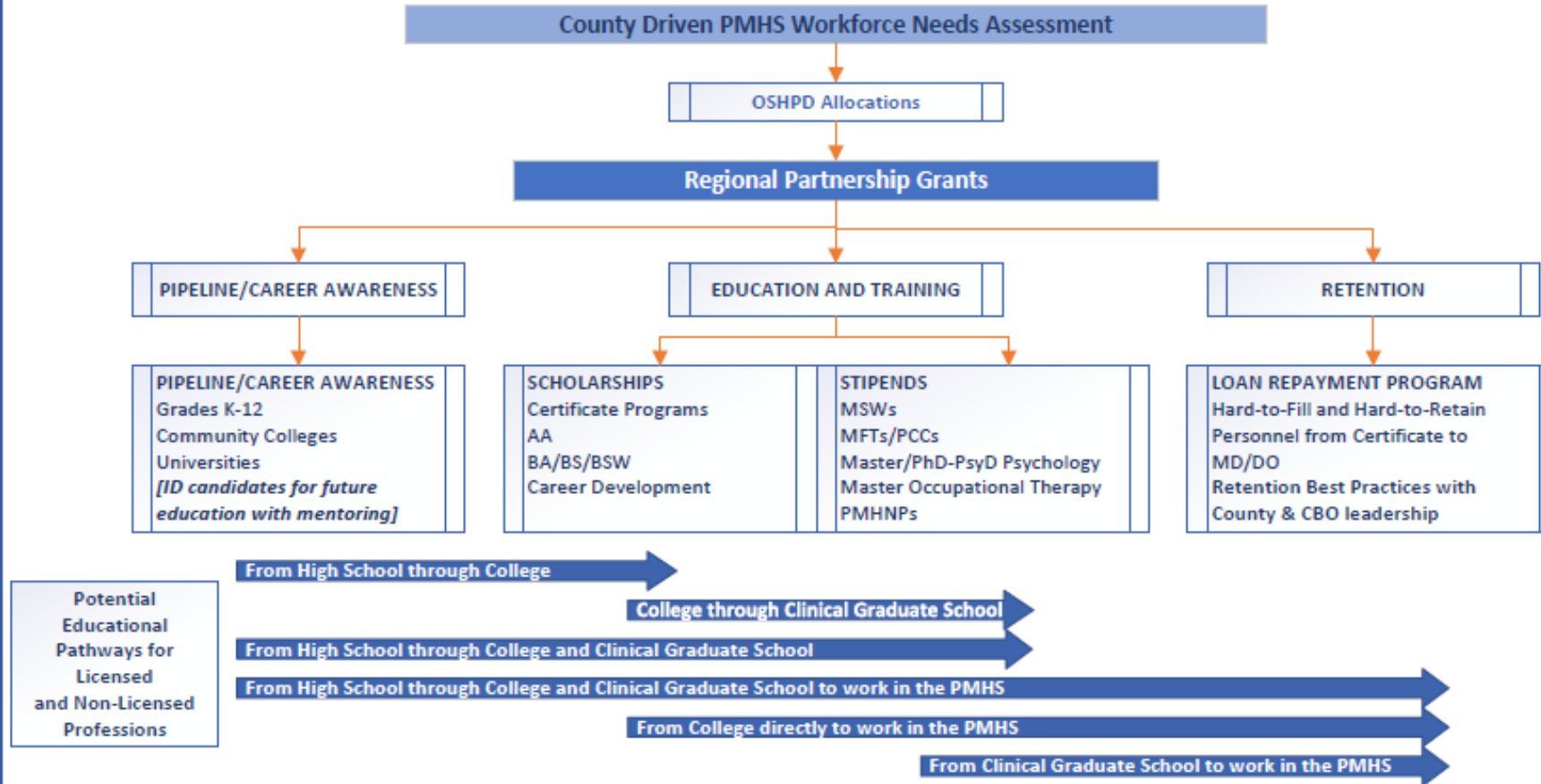

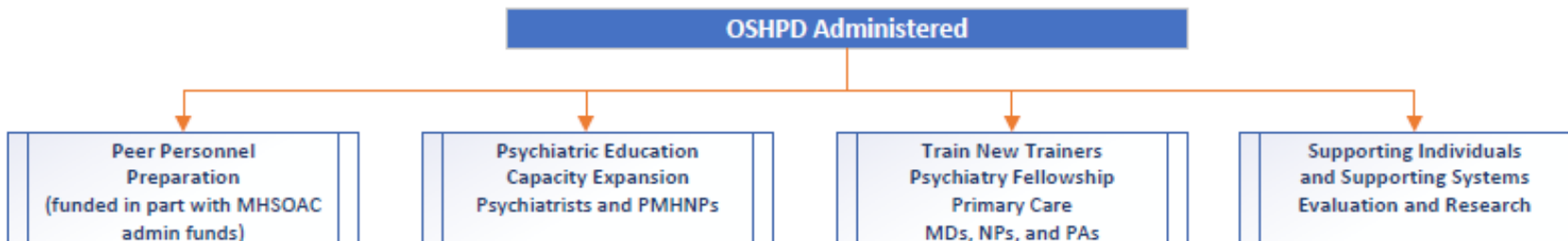

# Mental Health Services Act (MHSA) WET

## Program:

### Background

- Regional Partnership (RP) Grant Program:
  - \$40 million is being made available in Fiscal Year (FY) 2021-2025.
- Psychiatric Education Capacity Enhancement (PECE) Grant Program:
  - Up to \$18 million allocated to establish new training programs for FY 2020-2023, and to expand existing training programs for FY 2020-2025.

# RP Program

- The MHSA established the WET RPs to carry out activities in collaboration with region-level stakeholders (i.e., roving supervisors and pipeline programs).
- The former Department of Mental Health, with input from local mental health organizations, established the makeup of the Regional Partnerships in 2006.
- The 2020-2025 WET Five-Year Plan uses the RP structure to implement the ‘supporting individuals’ part of the Plan.



# RP Grant Program

- Pipeline Development
- Undergraduate College and University Scholarships (including professional development)
- Clinical Master and Doctoral Graduate Education Stipends
- Loan Repayment Program
- Retention

# Psychiatric Education Capacity Expansion (PECE) Grant Program: Objective

- Increase the supply of psychiatrists and psychiatric mental health nurse practitioners (PMHNP) trained to work in the local public mental health system (PMHS).
- Allocation among the funding categories will be based on evaluation scores, geographic considerations, and other factors.



# PECE Grant Program:

## Components

### New Programs

- Increase the number of psychiatry residency and PMHNP programs across California.

### Program Expansion

- Increase the number of psychiatry residents, child and adolescent fellows, and PMHNP students trained in the PMHS.

# PECE Grant Program:

## Psychiatry Residency Evaluation Criteria

- Establish Child and Adolescent Psychiatry Fellowship Program
- Average cost per resident/fellow based on total budget
- Percent of rotation hours in the PMHS per resident
- Expansion or New Program
- Percent of rotation hours in rural areas
- Historical PMHS involvement

# PECE Grant Program:

## PMHNP Training Evaluation Criteria

- Number of new nurse practitioners added
- Expansion or New Program
- Average cost per student based on total budget
- Percent of placement hours in the PMHS
- Percent of annual student hours in rural field placements
- Preceptor Arrangements
