PCSA Purpose

- Identify additional California shortage areas overlooked by federal HPSA designations
- Inform Song-Brown funding decisions
 - *Primary Care Residency*
 - *Family Nurse Practitioner and Physician Assistant (FNP/PA)*
- Evaluate graduates and training sites in areas of unmet need
 - *Clinical hours in areas of unmet need for FNP/PA*

PCSA Calculation

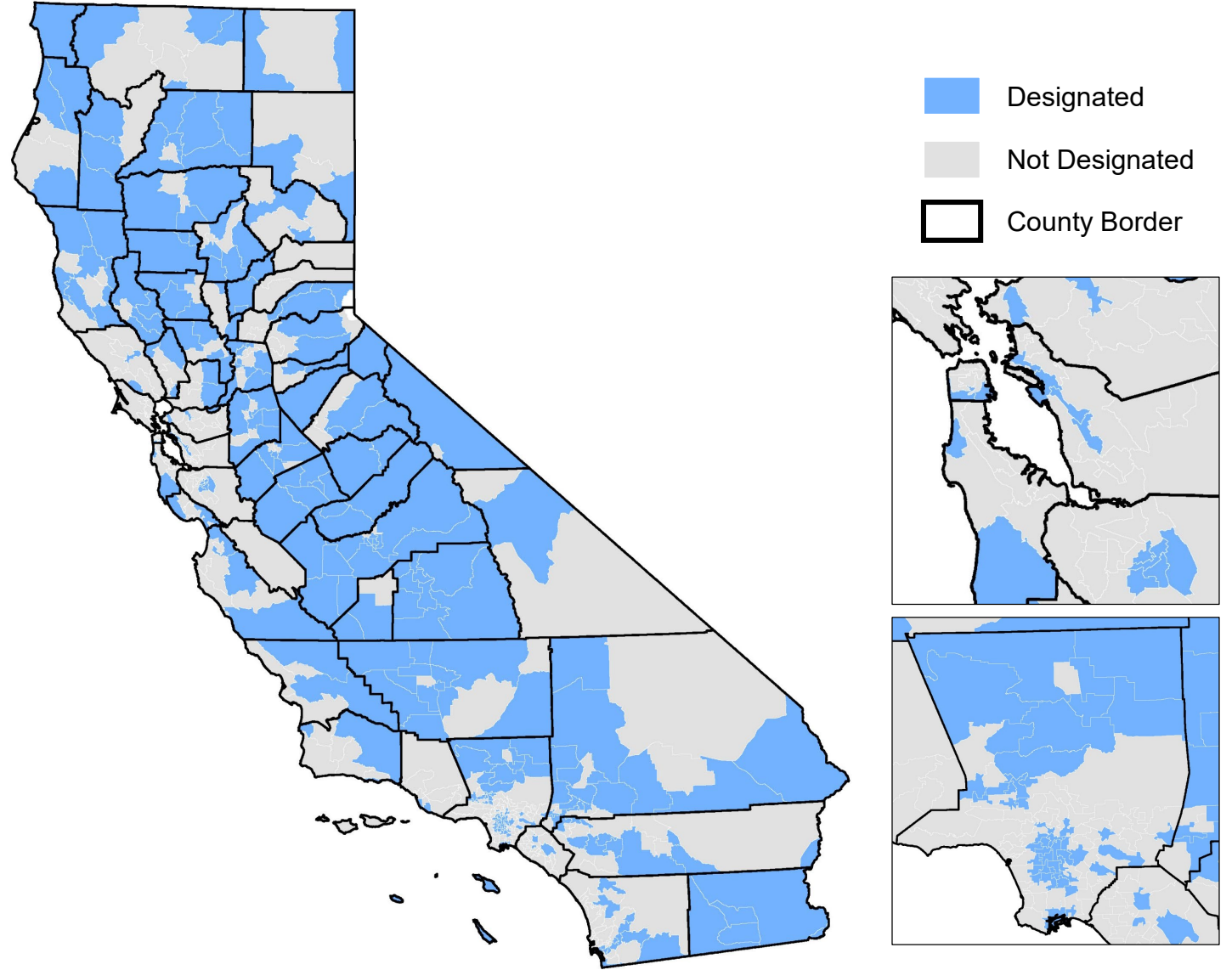
- Use Medical Service Study Areas (MSSA) to define physician shortages
 - *There are currently 542 MSSAs in California*
- MSSA factors evaluated for the updated PCSA
 - *Percent of population below 100% Federal Poverty Level (FPL)*
 - *Provider-to-population ratio*

Updated Provider Ratio

- Change from a physician-only ratio to a unified provider ratio approved by the Commission on June 13, 2019
- Family nurse practitioners and primary care physician assistants weighted at 0.75

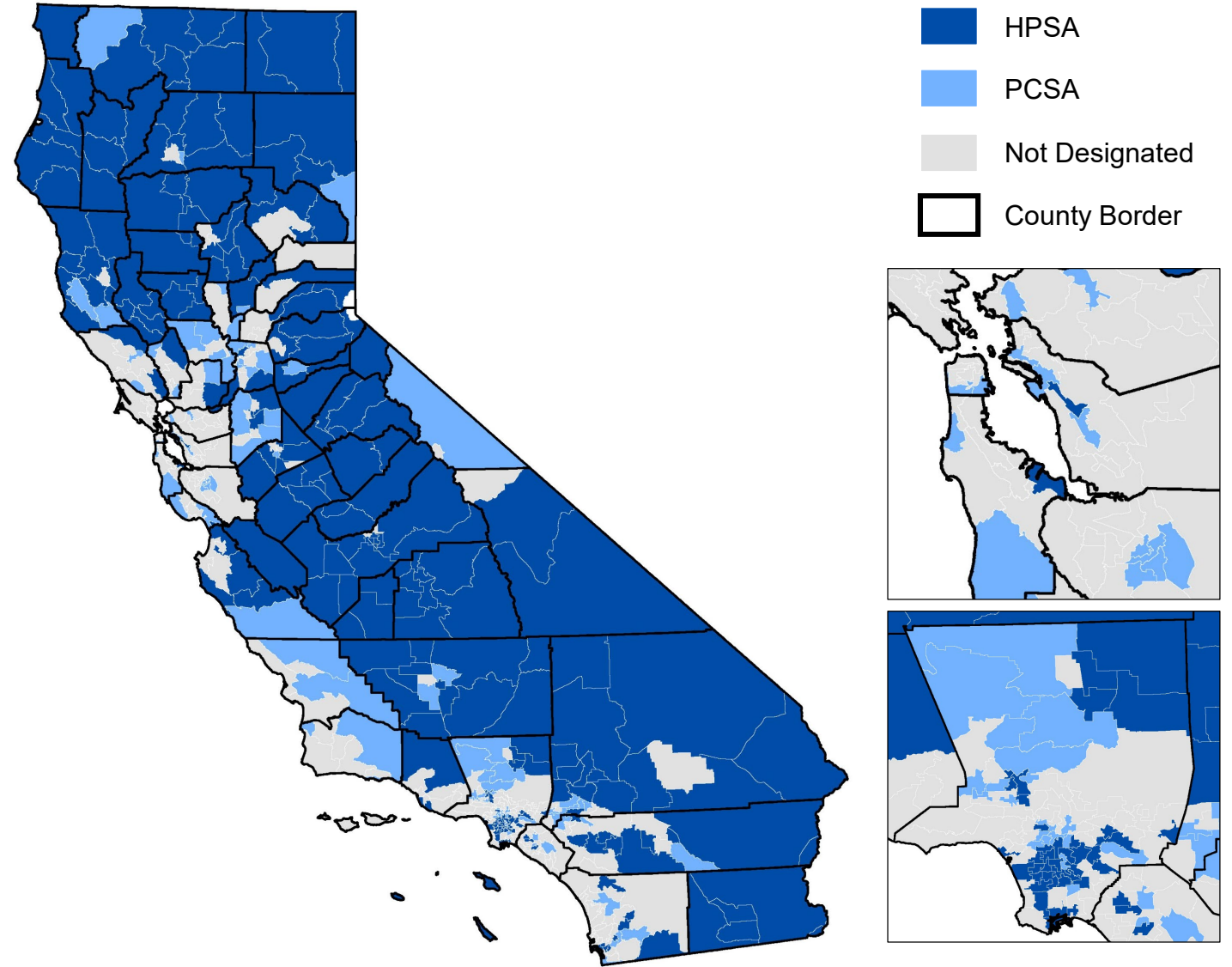
PCSA Results

- MSSAs designated as PCSAs: 268 (49%)
- Civilian population in PCSAs: 14.7 million (38%)



PCSA vs HPSA

- PCSAs designate 55 MSSAs on top of those designated as HPSAs
- MSSAs designated as PCSA or HPSA: 323 (60%)
- Civilian population in a PCSA or HPSA: 17.3 million (45%)



Decision

- Commission may choose to adopt the PCSA updates
- Effective starting application year 2020/21 to 2022/23

Subject: Primary Care Shortage Areas Report

Summary

In 2004, the California Healthcare Workforce Policy Commission (Commission) adopted formal criteria for designating Primary Care Shortage Areas (PCSA) using primary care physician counts and demographic data. During the June 2019 policy meeting, the Commission voted to modify the criteria to include weighted counts of family nurse practitioners (FNP) and physician assistants (PA). The Office of Statewide Health Planning and Development (OSHDP) refreshed the PCSA designations by applying the updated criteria to the most recently available data. Using the updated criteria and data, the methodology would designate 268 of California's Medical Service Study Areas (MSSAs)¹ as PCSAs.

Considerations

The Commission may adopt the revised PCSA designations.

Background and Methodology

The Commission uses PCSAs to inform Song-Brown Program funding decisions for Primary Care Residency and Family Nurse Practitioner/Physician Assistant training programs. OSHDP calculates a score for each MSSA according to criteria the Commission established. The criteria are (1) percent of the population living below the federal poverty level (FPL), and (2) the provider-to-population (P2P) ratio. Each component is worth up to five points. Table 1 summarizes the scoring rubric:

Table 1

Score	Percent of Population Below FPL	P2P Ratio
0	Less than 5%	Lower than 1:1,000
1	5 – 10%	1:1,000 – 1:1,500
2	10 – 15%	1:1,500 – 1:2,000
3	15 – 20%	1:2,000 – 1:2,500
4	20 – 25%	1:2,500 – 1:3,000
5	Greater than 25%	Higher than 1:3,000 or No providers

¹ MSSAs are geographic units based on population, demographic, and physician data. The Federal Health Resources Services Administration (HRSA) formally recognizes California's MSSA unit of geography as the Rational Service Area for medical service in California.

The Commission's methodology designates any MSSA with a total score greater than or equal to five as a PCSA.

Before 2019, OSHPD used data only from primary care physicians to calculate the provider-to-population ratio. In June 2019, in light of the increasing contribution of FNPs and PAs to primary care, the Commission voted to include these provider types in the provider ratio. Considering the current scope of practice laws and supervision requirements for these providers, the Commission further decided that for every one FNP or primary care PA, 0.75 would be added to the provider count. The formula for the updated ratio is:

$$\frac{\text{Civilian Population}}{\text{Physicians} + (\text{FNPs} \times 0.75) + (\text{PAs} \times 0.75)}$$

OSHPD obtained primary care physician counts from California's Primary Care Office (PCO), which conducts needs assessments for the state and determines what areas are eligible for federal shortage designations. As of January 2019, the PCO data contains 37,690 active primary care physicians.

OSHPD used the National Provider Identifier (NPI) Downloadable File from the Centers for Medicare & Medicaid Services to identify the number of FNPs and PAs. The January 2019 NPI data identifies 9,080 FNPs in California. With the Commission's weighting scheme, this adds 6,810 providers to the provider ratio. The NPI data identifies 11,358 total PAs but does not specify which are practicing primary care. The National Commission on Certification of Physician Assistants estimates that 32.4 percent of California's PA workforce practiced primary care in 2017, therefore OSHPD estimates there are about 3,680 primary care PAs in California. Using the formula, this adds 2,760 providers to the provider ratio.

OSHPD derived the poverty and population data from the Census Bureau's American Community Survey 2017 5-Year Estimate.

Results

The updated criteria and data designates 268 of California's MSSAs as PCSAs. Approximately 14.7 million people, or 38 percent of the population, live in these areas. Table 2 lists every MSSA and its PCSA score, sorted alphabetically by county:
