State of California-Issued CHW/P/R Certificate: Important Clarifications and Background





Important Clarifications about the State of California-Issued CHW/P/R Certificate

- The State CHW/P/R Certificate is **only required** to bill Medi-Cal for Medi-Cal reimbursable CHW/P/R services.
- The State CHW/P/R Certificate indicates that an individual has received training and education approved by the state for a CHW/P/R.
- CHW/P/Rs *can* continue to work without the State CHW/P/R Certificate.







Community Health Worker (CHW) services as a Medi-Cal benefit

California Legislature and the Administration wanted to provide payment for CHW services through our state's Medi-Cal program. To do so, DHCS, the state's Medi-Cal department, had to define the CHW benefit and create the rules for payment of services including a state-issued certificate through a State Plan Amendment.

Per California statute, HCAI **must develop statewide requirements** for community health worker certificate programs **in consultation with stakeholders.**



Through this stakeholder engagement, stakeholders will help HCAI develop requirements for:

- Self-attestation of lived experience
- CHW/P/R training programs
- Legacy CHW/P/R work experience
- Specialty programs

Frequently Asked Questions (1 of 3)

State CHW/P/R Certificate

□ What is the purpose of the State CHW/P/R certificate?

- The California Department of Health Care Access and Information (HCAI) is developing the State-Issued CHW/P/R certificate process that can be used to bill the CHW Medi-Cal Benefit, when implemented.
- The State-Issued CHW/P/R Certificate indicates that an individual has received training and education approved by the state for a CHW/P/R or the individual has the experience demonstrating they possess the core competencies to be a state certified CHW/P/R.
- □ Who is the entity authorized to establish a process for the State-Issued CHW/P/R Certificate?
 - HCAI will be the certifying entity.
- How will individuals be certified as a CHW/P/R by HCAI?
 - HCAI will create two pathways to certify individuals as CHW/P/Rs, a Training Pathway and a Legacy Pathway. HCAI will approve CHW/P/R training programs based on requirements developed through the stakeholder engagement process.
 - The Legacy Pathway will provide current CHW/P/Rs with an opportunity to become state certified if they demonstrate they meet the core competencies, outlined in the state requirements under development.
- Do all CHW/P/Rs need to be certified by HCAI to continue working?
 - A State-Issued CHW/P/R Certificate is not needed to continue working. the State-Issued CHW/P/R Certificate will demonstrate that the CHW/P/R has the training to bill Medi-Cal for the CHW Medi-Cal Benefit.
- □ What is the start date for the State-Issued Certificate?
 - HCAI expects to begin issuing CHW/P/R certificates in Fall 2023.
- □ How much will a State-Issued Certificate cost?
 - HCAI has clearly heard from stakeholders that the certificate needs to be affordable. HCAI is committed to implementing this stakeholder feedback as we plan for sustainability of the state certification process.





Frequently Asked Questions (2 of 3)

Legacy Pathway

- □ What is state certification going to look like for existing CHW/P/Rs the Legacy Pathway?
 - The Legacy Pathway will be one of two ways people can receive a State-Issued CHW/P/R certificate. HCAI will seek to ensure the Legacy Pathway is not an unreasonable barrier for currently practicing CHW/P/Rs, but this pathway MUST demonstrate that a legacy CHW/P/R has the core competencies to be a state certified CHW/P/R.
 - HCAI is using stakeholder feedback and information from other states to inform the Legacy Pathway requirements.

Specialty Certificate

- What areas will the Specialty Certificate cover?
 - There will be a certificate for specializations of specific groups (e.g., justice-involved, domestic violence survivors, LGBTQ+) that are being determined through stakeholder engagement. We expect to work with training programs that focus on specialization (e.g., Alzheimer's, climate change). The stakeholder engagement process will assist us in identifying priorities for specialized training and developing statewide requirements.
- □ Is the Specialty Certificate required for billing for the CHW Medi-Cal Benefit?
 - No, the Specialty Certificate is an optional add-on to support CHW/P/Rs in working with specific communities and/or to work with individuals with particular health conditions.
- □ What does the Specialty Certificate indicate?
 - The Specialty Certificate indicates that a CHW/P/R has completed additional training that concentrates on specific program focus areas, with learning objectives and topics tailored to the skills required for distinct program and population needs.





Frequently Asked Questions (3 of 3)

HCAI Approved CHW/P/R Training

- When will HCAI release the requirements for the state certificate of CHW/P/Rs and approving training programs that will train individuals to become state certified CHW/P/Rs?
 - HCAI will release the requirements for certifying CHW/P/Rs and the requirements for approving training programs in July 2023.
- How does the state certificate process affect training programs?
 - Any CHW/P/R wishing to become state certified, unless utilizing the Legacy Pathway, will need to complete an HCAI-approved training program.
- □ Will all training materials be presented in multiple languages?
 - HCAI recognizes the importance of ensuring training materials are in multiple languages. HCAI will approve training programs that provide stateapproved CHW/P/R training in multiple languages.
- □ What will the requirements for continuing education look like?
 - HCAI will set a requirement for a minimum of 6 hours of additional relevant training annually. Additional requirements for continuing education will be developed through the stakeholder engagement process.
- How and when will training programs apply to be approved by HCAI?
 - HCAI will outreach to known training programs and will also publicize the opportunity for training programs to submit materials on their programs for review. Training program requirements are currently being developed through stakeholder engagement and will be released publicly in July 2023. Submitting training programs who meet these requirements will be approved. HCAI anticipates that the training program submission/approval process will begin in Summer 2023.

Stakeholder Input

- □ How are CHW/P/Rs involved in the development of the state certificate process?
 - HCAI's stakeholder engagement process is meant to bring in the collective experience and voice to the process. HCAI has been delighted to see the high turnout of our stakeholders, including current CHW/P/Rs, who are helping inform the state certificate process.

State-Issued CHW/P/R Certificate

- □ The State CHW/P/R Certificate is *only required* to bill Medi-Cal for reimbursable CHW/P/R services.
- □ CHW/P/Rs *can* continue to work without the State CHW/P/R Certificate.
- **2** Pathways to State CHW/P/R Certificate:
 - Training Program Pathway
 - Legacy Pathway
- CHW/P/Rs will apply for the State CHW/P/R Certificate online, after meeting the Training Program Pathway or Legacy Pathway requirements

State-Issued CHW/P/R Certificate: Renewal

- □ CHW/P/Rs must renew their State CHW/P/R Certificate once every 2 years
- **CHW/P/Rs** will apply for renewal online, after completing continuing education requirements

State-Issued Specialty Certificate

- □ An *optional* add-on to the State CHW/P/R Certificate (for both Training Program Pathway and Legacy Pathway).
- □ NOT required to bill Medi-Cal for Medi-Cal reimbursable CHW/P/R services
- **CHW/P/Rs** will apply for the State Specialty Certificate online, after meeting the State Specialty Certificate requirements

State-Issued CHW/P/R Certificate: Training Program Pathway (DRAFT)

Training Program Pathway Requirements

✓ Self-Attestation of Lived Experience

- The CHW/P/R attests they will provide CHW/P/R services with individuals, communities, populations that align with their lived experience
 - "Lived experience" can be:
 - Personal knowledge of a specific health condition or circumstance
 - Part of someone's self-identity, such as a member of a race/ethnic community or the LGBTQ+ community

✓ Completion of an HCAI-approved training program, which will provide:

- o Minimum 80 hours of training (80 hours must include a minimum of 5 hours of unpaid field experience)
 - Field experience hours are defined as: hours in the field training as a CHW/P/R under supervision
- Curriculum that teaches to core competencies, adopted from C3's core competencies
- A training team that includes at least one CHW/P/R as a trainer, co-trainer, or other member of the training team
- o Assessment of core competencies at the end of the training (test, supervised field experience, or other assessment)
- Support for CHW/P/Rs applying to the certifying entity to receive the State CHW/P/R Certificate



State-Issued CHW/P/R Certificate: Training Program Pathway (DRAFT)

Core Competencies for Training Program Curriculum

□ HCAI-approved training programs will provide curriculum that teaches to the following core competencies (modeled off of C3's core competencies)

- Communication Skills
- Interpersonal and Relationship Building Skills
- Service Coordination and Navigation Skills
- Capacity Building Skills
- Advocacy Skills
- Education and Facilitation Skills
- Individual and Community Assessment Skills
- Outreach Skills
- Professional Skills and Conduct
- Evaluation and Research Skills
- Knowledge Base (basic knowledge in public health principles and social determinants of health, as determined by the supervising provider)





State-Issued CHW/P/R Certificate: Training Program Pathway (DRAFT)

State-Issued CHW/P/R Certificate: Legacy Pathway (DRAFT)

Legacy Pathway Requirements

✓ Self-Attestation of Lived Experience

- The CHW/P/R attests they will provide CHW/P/R services with individuals, communities, populations that align with their lived experience
 - "Lived experience" can be:
 - Personal knowledge of a specific health condition or circumstance
 - Part of someone's self-identity, such as a member of a race/ethnic community or the LGBTQ+ community

✓ 2,000 hours of CHW/P/R work in the past 3 years

• CHW/P/R will submit proof of 2,000 hours of CHW/P/R work (employment or volunteer) in past 3 years

✓ 2 letters of recommendation attesting to CHW/P/R Core Competencies

- CHW/P/R will submit 1 letter of recommendation from Organizational Leader where they have worked or volunteered
- CHW/P/R will submit 1 completed form letter from Direct Supervisor
 - Form letter template will be supplied by certification entity
 - Direct Supervisor will attest to the applicant's competencies in core areas by checking off boxes for each competency and providing signature





State-Issued CHW/P/R Certificate: Legacy Pathway (DRAFT)

The Legacy Pathway MUST demonstrate that the individual meets the core competencies to receive a State CHW/P/R Certificate. HCAI believes the model, as outlined, meets this standard.

State-Issued CHW/P/R Certificate: Renewal (DRAFT)

Renewal Requirements

✓ CHW/P/R must renew their State CHW/P/R Certificate once every 2 years

✓ Renewal of Self-Attestation of Lived Experience

- The CHW/P/R will again attest that they will provide CHW/P/R services with individuals, communities, populations that align with their lived experience
 - "Lived experience" can be:
 - Personal knowledge of a specific health condition or circumstance
 - Part of someone's self-identity, such as a member of a race/ethnic community or the LGBTQ+ community

✓ Six hours each year of continuing education, from an HCAI-approved training program. All HCAI-approved continuing education training programs will provide:

- Continuing education focused on:
 - Core competency topics
 - Updates on applicable laws, e.g. changes in Medi-Cal eligibility, and evidence based best practices.
- Support for CHW/P/Rs applying for renewal of their State CHW/P/R Certificate

State-Issued Specialty Certificate

State-Issued Specialty Certificate Requirements

✓ CHW/P/R meets requirements for State CHW/P/R Certificate

- ✓ Completion of HCAI-approved specialty CHW/P/R training program.
 All HCAI-approved specialty training programs will provide:
 - Curriculum in the area of specialization
 - 10 hours of specialty training beyond the 80 hours required for core CHW/P/R training
 - Specialty trainings may be offered with the core CHW/P/R training, or as separate training units
 - CHW/P/Rs using the Training Program Pathway can take specialty training(s) with core CHW/P/R training
 - CHW/P/Rs using the Legacy Pathway can take specialty trainings that are offered as separate units





State-Issued Specialty Certificate
