



## Allied Healthcare Loan Repayment Program (AHLRP)

AHLRP is funded by the County Medical Services Program (CMSP). Applicants may receive loan repayments of up to \$16,000 in exchange for a 12-month service obligation practicing direct patient care in a qualifying occupation at a CMSP-contracted provider site in any CMSP county.

**Application Timeline** – May 1, 2025, 3:00PM – June 30, 2025, 3:00PM

## Allied Healthcare Loan Repayment Program (AHLRP)

## **Additional Program Requirements** – AHLRP applicants must:

- Be in good standing with their respective licensure, board, or certification
- Not have any other existing service obligations with other entities, including other HCAI programs
- Not be in breach of any other health professional service obligation
- Have unpaid educational loans
- Commit to providing a 12-month service obligation at a CMSP-contracted provider site
- Provide 32-hours or more per week of direct patient care
