Community Dialogues Overview


Launch: February 2024 CalHHS, HCAI, and DHCS began statewide dialogues.

Purpose:

- **Broad Representation:** Engage CHW/P/Rs, communities, and related organizations across the state and covering a broad range of role types and communities served.
- **Identify Needs:** Focus on workforce competency and professional growth.

Expected Timeline: Feb - Fall 2024 of statewide sessions.

Goal: Guide solutions and investments for the CHW/P/R workforce.





Sample Dialogue Questions


During the dialogues, discussions have taken place with the community to identify needs and brainstorm possible solutions. Below, are types of questions being discussed at the sessions. Please note this is not an exhaustive list.

- 1. What skills, knowledge, and resources do you need to support your professional development as a CHW/P/R and to help you stay in the field?
- 2. What does that support look like and who should be responsible for providing it?
- 3. Would a statewide certificate or state funded training meet your needs? If so, how? If not, why?
- 4. Are there any other solutions that the state should consider to support your professional advancement and skill development?

Dialogue Host Selection Process

Dialogue sessions and host sites were selected with attention to addressing both geographic distribution (urban and rural) and coverage of the wide array of CHW/P/R types and the diverse communities they serve. This approach includes a comprehensive outreach plan aimed at addressing regional health needs.


Timeline & Coverage:

- Feb-May 2024 (Red Pins): Northern, Central, Southern CA
- Sept-Oct 2024 (Purple Pins): Expanded statewide coverage (In progress and Expected)

Note: The pins are indicative of host site address and their community reach extends beyond that location. For example, some pins in the Northern area represent host sites that serve communities from the Northern California region.


