





#### Race & Ethnicity of California's Health Workforce








Justice-System Involved Youth: BH Pipeline (JSIY BH)

Advise HCAI on investment priorities for pathway programs to diversify and expand California's behavioral health workforce

- 2. Evaluate HCAI pathway programs
- 3. Develop recommendations to guide investments

### **Phase 1 – Pathway Program Landscape Assessment**

Pathway Program Scan & Literature Review	<ul><li>Scholarly &amp; Grey</li><li>National, interdisciplinary</li></ul>
Landscape synthesis	<ul> <li>Program characteristics</li> <li>Program effectiveness</li> <li>Promising programs</li> </ul>
Key informant interviews	<ul> <li>Real world insights</li> <li>Informants identified through review and HCAI/sponsor feedback</li> </ul>
Outputs	<ul><li>Interim findings to HCAI</li><li>Short report Fall 2025</li></ul>



### Phases 2 & 3

#### **Phase 2 - Baseline Evaluation**

- Develop framework to assess HCAI's pathway program investments
- Analyze key program elements
- Review administrative data & conduct discussions with program leaders
- Expected output: Internal short report to HCAI

#### **Phase 3 - Recommendation Development**

- Develop investment priorities & program design guidance
- Recommend grant review strategies & evaluation considerations
- Incorporate HCAI feedback for final recommendations
- Expected output: Final report to HCAI
