Egress points shall be at least 90° apart as measured from the center NFPA 418, of landing pad, remotely located not less than 30' apart with no two Sec. 5.5.1, 5.5.2, egress point located on the same side of the roof top landing pad. 5.5.3 & 5.5.4 Means of egress shall not obstruct flight operations. \square 4. When landing platforms or roof areas are less than 60' in length CBC, Sec. or less than 2,000 sq. ft. in area, the second means of egress 412.7.3 may be a fire escape, alternating tread device or ladder leading to the floor below. 5. The heliport shall have at least two access points for firefighting/rescue personnel. The access points shall be located NFPA 418. at least 90 degrees from each other as measured from the center Sec. 4.4.1 of the landing pad. \square The landing area for helicopters less than 3.500 pounds shall be 6. CBC, Sec. not less than 20 feet in length and width. The landing area requirements for helicopters of 3,500 pounds or NFPA 418, Sec. larger are enforced by the Federal Aviation Administration, 4.2.2 Department of Transportation. Landing areas shall be designed to confine fuel spills to the CFC, Sec. landing area and shall drain away from exits, stairways or from a 2007.3 & CBC. structure housing such exit or stairway. The rooftop landing pad shall be pitched to provide drainage at a NFPA 418, Sec. slope of 0.5% to 2% in order to protect, at a minimum, the primary 5.3 & Sec. 5.3.1 egress path, passenger holding area, firefighting access points and fire protection activation systems. **10.** Drainage flow from the rooftop landing pad shall not penetrate NFPA 418, Sec. alternate egress points, stairways, ramps, hatches and other 5.3.2 openings not designed for drainage. **11.** The pitch of the pad shall not be required where the pad consists NFPA 418, Sec. of a passive fire protection grid surface designed and listed for 5.3.3 fuel catchment and containment. **12.** Helicopter landing areas and the supports thereof on the roof of a CBC, Sec. building shall be noncombustible construction. 412.7.2 NFPA 418, Sec. **13.** Main structural support members that could be exposed to a fuel spill shall be 2-hour rated fire resistant construction. 5.2 \square 14. The rooftop landing surface shall be constructed of approved NFPA 418, Sec. noncombustible, nonporous materials. 5.4.1
