Pursuant to the requirements of Government Code sections 11346.8(c) and 11347.1, and Section 44 of Title 1 of the California Code of Regulations, the Department of Health Care Access and Information (HCAI) hereby provides notice of changes made to the proposed regulations in Chapter 11, "Health Care Payments Data Program" (Sections 97300-97370) of Division 7 of Title 22 of the California Code of Regulations regarding the collection of data for the Health Care Payments Data Program (HPD).

The text of the regulations with proposed modifications is attached to this Notice. The revisions are substantially related to the original proposed text and include updating the implementation date of the All-Payer Claims Database (APCD-CDL™) Version 4.0.1 to March 31, 2026. HCAI also revised the Health Care Payments Data Program: Data Submission Guide Version 4.0 which is incorporated by reference to update the implementation date to March 31, 2026, and update submission requirements for the Pharmacy Rebate and Capitation File Fields. The modified proposed regulation text and Data Submission Guide Version 4.0 are available for public review and comment for a period of at least 15 days prior to adoption of these proposed regulations.

All modifications are noted with a double underline for new language and a double strikethrough for removed language. The modified proposed regulation text and Data Submission Guide Version 4.0 are available for public inspection at the address stated below Monday through Friday, 8:00 am to 5:00 pm, by contacting the HCAI point of

contact identified below, or on the HCAI website at <https://hcai.ca.gov/about/laws-regulations/>. These documents will be available during the entire comment period described below.

The Department will consider public written comments regarding the changes made to the proposed regulations and the new document added to the rulemaking file beginning November 3, 2025, and ending November 18, 2025. All written comments pertaining to the proposed modification must be received by HCAI on or before November 18, 2025.
