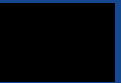

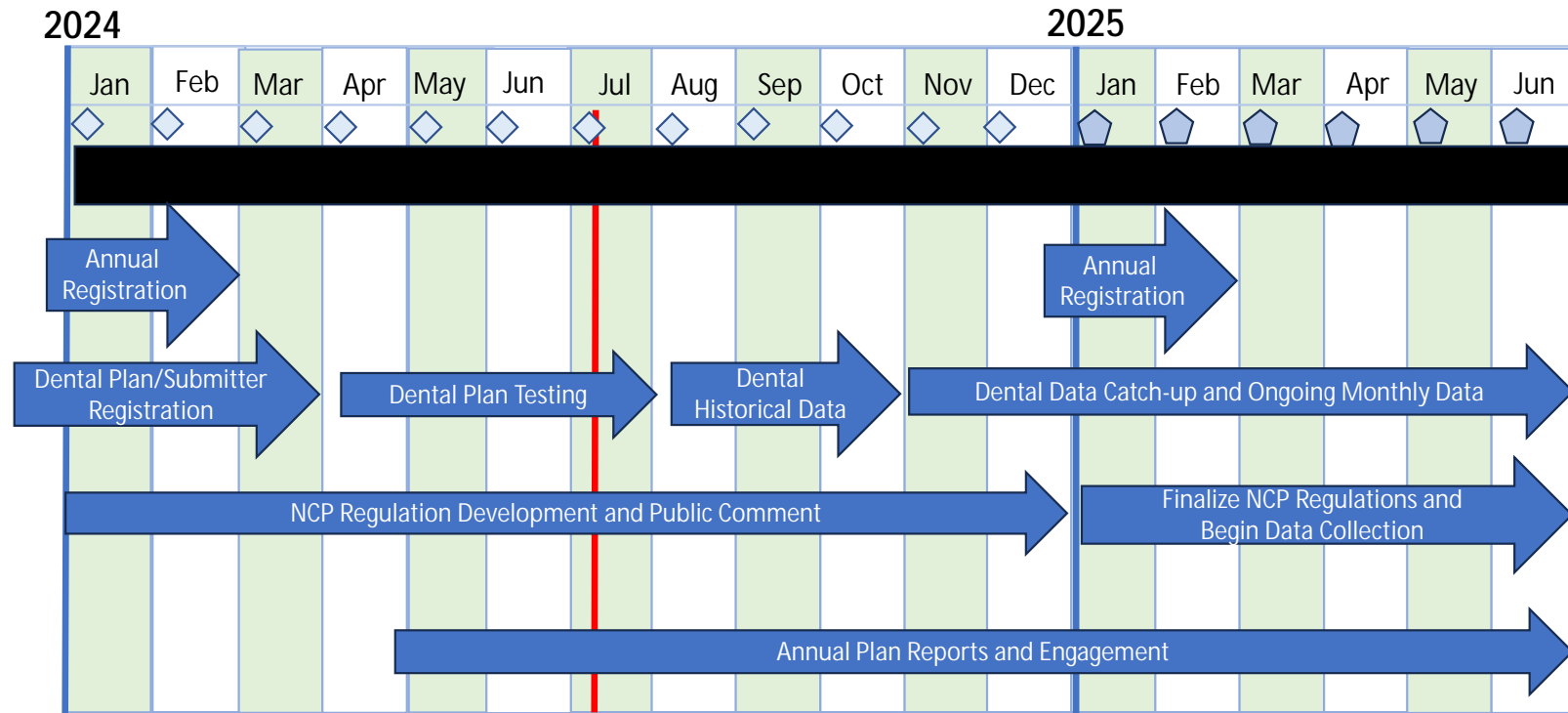

HPD Timelines for 2024-2025



Regulations Reminder

- HPD data collection regulations were certified on November 17, 2023
 - [California Code of Regulations Sections 97300-97370](#)
- Regulations will need to be updated with additions of new data collection requirements and/or for each biennial release of the All-Payer Claims Database-Common Data Layout (APCD-CDL)

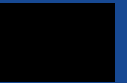

Status of Production File Submissions

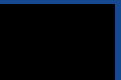

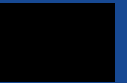


HPD Program – Submission Status (2024)

- Monthly production submissions as of 7/8/2024.
 - January(03/01/2024) - 36 of 38 submitters
 - February (04/02/2024) - 36 of 38 submitters
 - March (05/01/2024) - 36 of 38 submitters
 - April (06/03/2024) - 35 of 38 submitters
 - May (07/01/2024) - 35 of 38 submitters

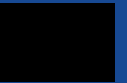
Variance Request

- FAQ #12 - Will a submitter be able to apply for a temporary data variance, if they are unable to comply with the current Data Submission Guide?
 - Yes. The process for requesting a temporary data variance is included in [California Code of Regulations Section 97370](#). A data variance is intended to allow a submitter relief from specific requirements for a *limited time* while they enhance their data collection processes. Information on how to request a data variance is also included in the [HPD Reporting Manual 2.1](#).
- When submitting a [variance request](#), the request shall clearly indicate the following:
 - Current issues
 - The plan for correction
 - The anticipated date of correction

Data Quality Assurance and Improvement

Annual Reports and Plan Engagement Updates

- The reports include:
 - Executive summary
 - Data tables, visuals, summary analyses and questions
 - Completeness Rates for key metrics
 - Unique covered lives count trend analysis.
 - Submission timeliness and Variance requests analyses
- Data quality team met with our first plan and presented their reports and findings.
- Currently, we are designing Annual Reports for several other plans.

Data Quality Assurance and Improvement

NAHDO Data Quality Study

- HCAI is funding a new NAHDO data quality study on completion of key metrics by payer breakout
 - Refresh [NAHDO's 2019 study](#) with more measures and more State participation (19 States)
 - State comparison of key metrics and establishing benchmarks
- Timeline and process
 - Finalized the list of the key metrics and definitions of numerators and denominators during the first quarter of 2024
 - HCAI provided California's data to NAHDO in May 2024
 - Expected delivery timeline for NAHDO's public report is in Fall 2024

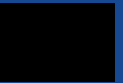
NAHDO Data Quality Study Measures

- Completion rate of key metrics
 - Number of covered lives
 - Percent of enrollment records with valid Race, Ethnicity, Language, and SSN
 - Percent of medical service lines with valid Procedure code, Revenue Code, Rendering National Provider Identification (NPI), and Place of Service
 - Percent of medical claims with valid Principal Diagnosis code, Secondary Diagnosis Code, Type of Bill, and Billing NPI
- Two survey questions
 - Does your APCD collect Sexual Orientation and Gender Identity (SOGI) data currently?
 - Is your organization currently using the APCD-CDL as its APCD data submission guide or reporting manual?

Non-Claims Payment (NCP) Updates

Non-Claims Payment Regulations

- Non-claims payments (NCP) are identified as information that mandatory submitters must provide to HPD as described in [Health and Safety Code section 127673](#)
- NCP regulations anticipated to be completed by 2025
 - Two surveys were sent to gather feedback: (1) timeframes for submitting certain data files and (2) potential economic impact for complying with NCP data collection

Anticipated Timeline for Non-Claims Payment Data Collection

- Historical data collection: HCAI is required to seek data three years prior to the effective date of [HPD enabling statute](#)
 - Annual payment and pharmacy rebate files due by July 31, 2025
 - Historical capitation files due by September 1, 2025
- Ongoing annual payment and pharmacy rebate files
 - September 30, 2025
- Initiation of monthly capitation file
 - October 1, 2025

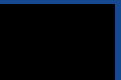
Using Onpoint Claims Data Manager

- Snapshot view of submitter data and statuses
- Review quality and completeness reports
- Request variances
- View submission status reports
- Update contacts
- Support and documentation



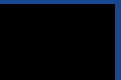
Prerequisites for Portal Access & Submitting Files

- Completed and approved submitter registration(s)
- Submitter code(s) incorporated into submissions
- Successful sign-in to the claims data manager (CDM)
- Public PGP key sent to Onpoint for data encryption
- If submitter will be sending data via SFTP:
 - Public SSH key sent to Onpoint for SFTP connectivity
 - Confirmation from Onpoint of SFTP account creation

February 29, 2024	Health submitter (non-dental) registration deadline

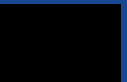
Test PGP Encryption As Soon As Possible

- Submit a test file to verify successful encryption and decryption
- Test early to avoid file transfer obstacles later in the implementation



Submit Real, Complete Production Data to “test”

- After submitters confirm successful PGP encryption, Onpoint recommends submitters use real, complete production data to verify submission mappings
- Benefits of “testing” with real, complete production data:
 - Variances can only be applied to real, complete production data (not test environment or dummy data)
 - Submitters will gain a full understanding of how their dataset performs against CDM’s automated data quality validations
 - Once a test file with real, complete production data passes CDM’s data quality validations, that file can be used as a production submission

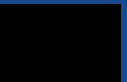


Monitor Program Compliance

- Track your submission progress...
 - In [CDM](#)
 - Through review of automated emails detailing submission status
- Review your data's formatting, completeness, and validation results
- Remediate mapping issues and request variances when necessary
- Reach out to [Onpoint](#) for support in reviewing your file

Be Detailed in Your Variance Requests

- Provide specific...
 - Explanations
 - Reporting periods applicable
 - Threshold adjustment required
- If applicable, provide your plan for future remediation
- Only request variances on real and complete production data



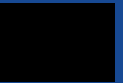
