#### **Regulations Reminder**

- HPD data collection regulations were certified on November 17, 2023
  - <u>California Code of Regulations Sections 97300-97370</u>
- Regulations will need to be updated with additions of new data collection requirements and/or for each biennial release of the All-Payer Claims Database-Common Data Layout (APCD-CDL)
- Stay up-to-date on HPD regulations by reviewing the <u>HPD Program</u> and <u>Submitter Group</u> pages, Newsletter, and Listserv blasts

#### Variance Request

- When submitting a <u>variance request</u>, the request shall clearly indicate the following:
  - Current issues
  - The plan for correction
  - The anticipated date of correction



### Dental Implementation

Dental Implementation Dates in Regulation	
DESCRIPTION	DATE
A dental plan must complete its initial registration with the Program by	03/29/24
Dental plans shall successfully complete the testing process by	07/31/24
All plans shall submit dental data for the time period from June 29, 2017, though December 31, 2021, by	10/31/24
Begin regular monthly reporting of dental data for the month of November 2024 by	01/02/25
Submit all remaining dental data for period beginning January 2022 through October 2024 by	02/01/25

#### Reporting Manual 2.1 Updates

- Subsection 5.20 Race and Ethnicity Data Elements Updates
- Race and Ethnicity
  - APCD-CDL ™, Version 3.0.1, uses CDC Race & Ethnicity Code System Version 1.2.
  - Submitters should use a code which best represents a member.
  - Concept codes used should be six-characters in length and must be as granular as possible.
  - Value 'UNKNOW' should only be reported when a member self-reports as unknown race or ethnicity.
  - Use a null value if the data was not available or was not collected.

## Non-Claims Payment Update

### Non-claims Payment Regulations

- Non-claims payments (NCP) are identified as information that mandatory submitters must provide to HPD as described in <u>Health</u> and Safety Code section 127673
- NCP regulations anticipated to be completed by 2025
  - Two surveys sent to gather feedback: timeframes for submitting certain data files and potential economic impact for complying with NCP data collection
- NCP data layouts update
- Updated FAQ Section on the <u>HPD Webpage</u>
  - <u>NCP Fact Sheet</u>
