Program Overview

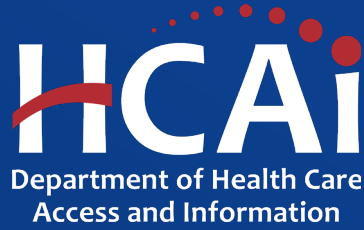
[Health and Safety Code Section 1339.85-1339.87](#) requires the Department of Health Care Access and Information (HCAI) to develop and administer a Hospital Supplier Diversity Reporting Program to collect and post hospital supplier diversity reports explaining the hospital's supplier diversity statement and procurement efforts regarding certified minority, women, lesbian, gay, bisexual, transgender (LGBT), and disabled veteran business enterprises.

Hospitals, with operating expenses over a specified amount, are required to annually submit a report to HCAI on their minority, women, LGBT, and disabled veteran business enterprise procurement efforts. HCAI is required to maintain a link on the HCAI website that provides access to the content of hospital supplier diversity reports to the public. The second annual submission of supplier diversity reports was due on July 1, 2022.

2021 Data Summary Overview

- This report summarizes data extracted from the second-year Hospital Supplier Diversity reports that were collected for the 2021 report period (1/1/2021 – 12/31/2021).
- The data summary is separated into two categories:
 - **Individual Hospital Reporting:** Individual reports are required for each licensed hospital with operating expenses of \$50,000,000 or more, and for hospitals with operating expenses of \$25,000,000 or more that are part of a hospital system.
 - **System Level Reporting:** System level reports are an optional report for hospitals to submit procurement done at a regional network or hospital system level.

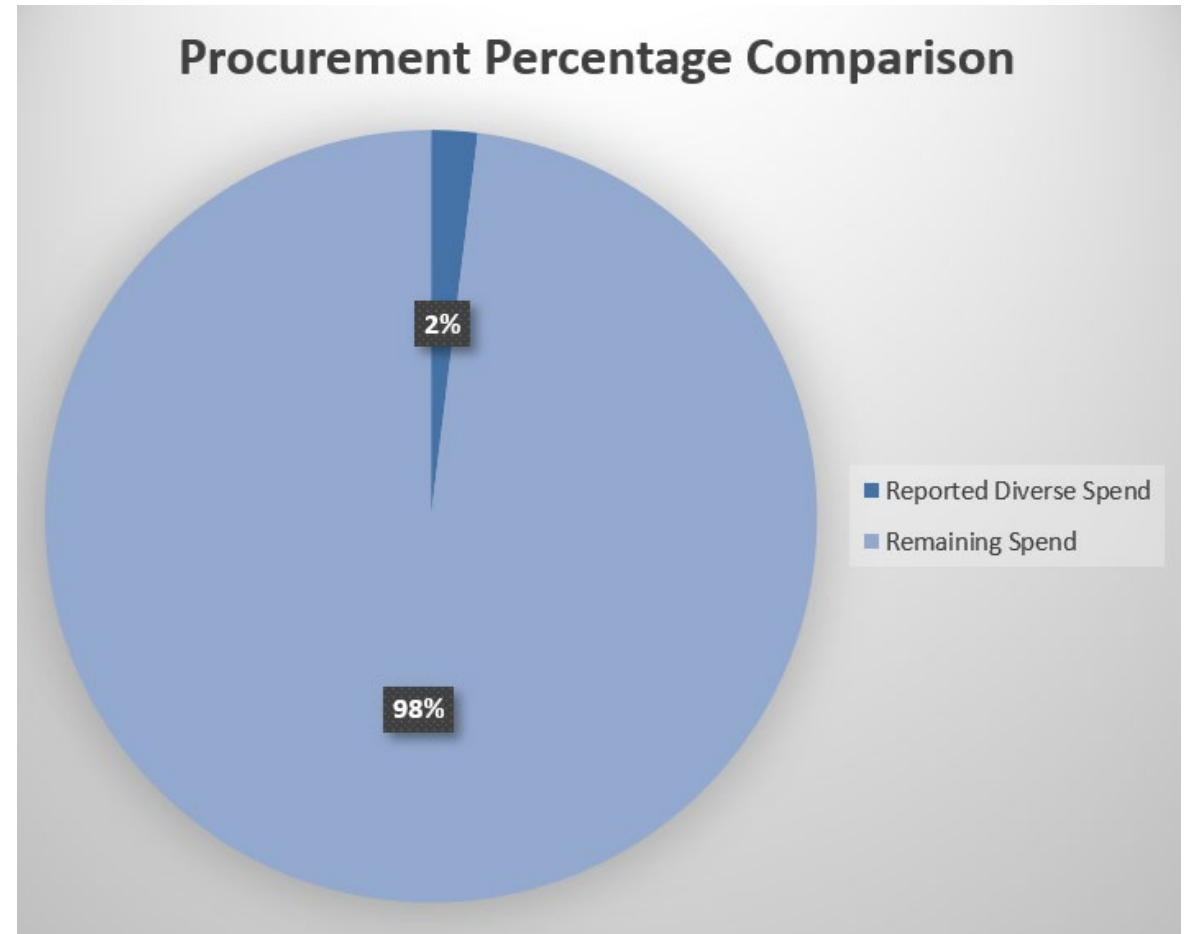

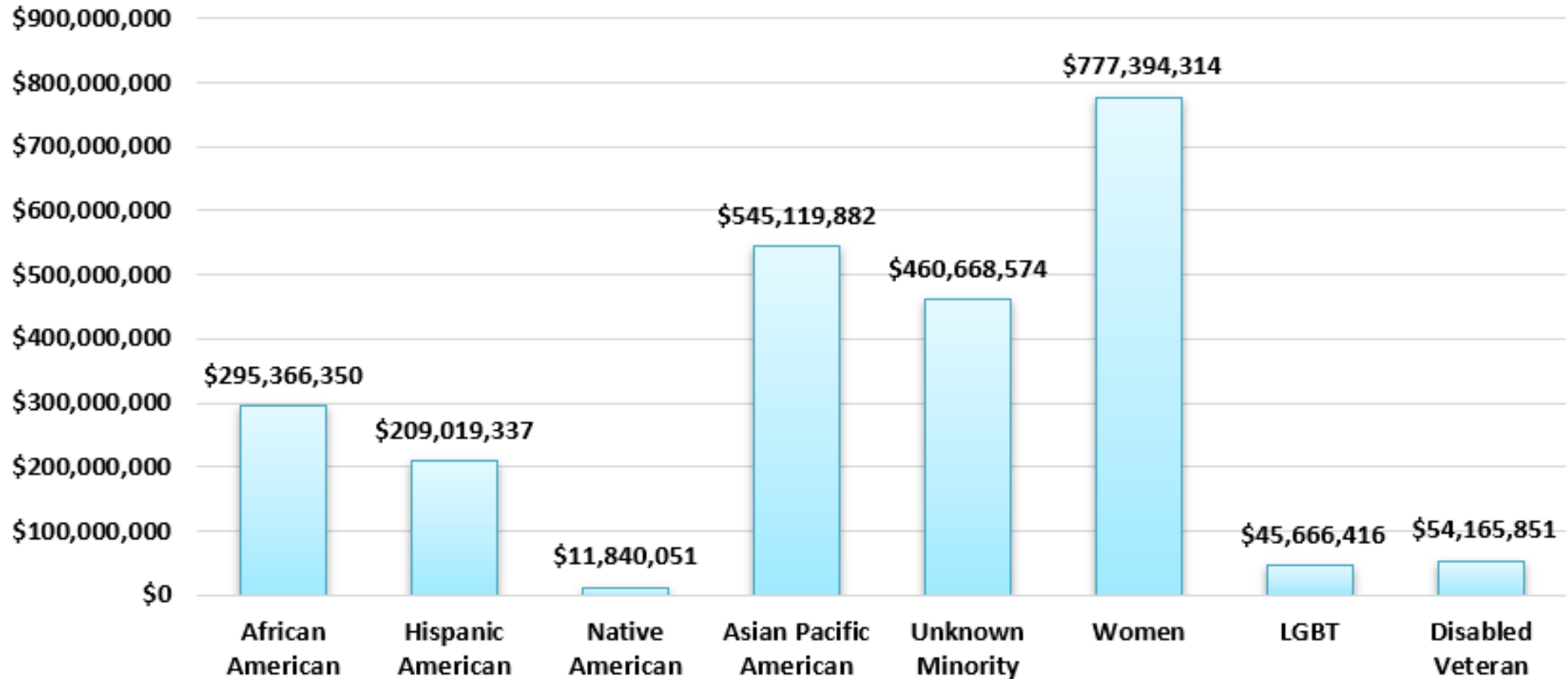

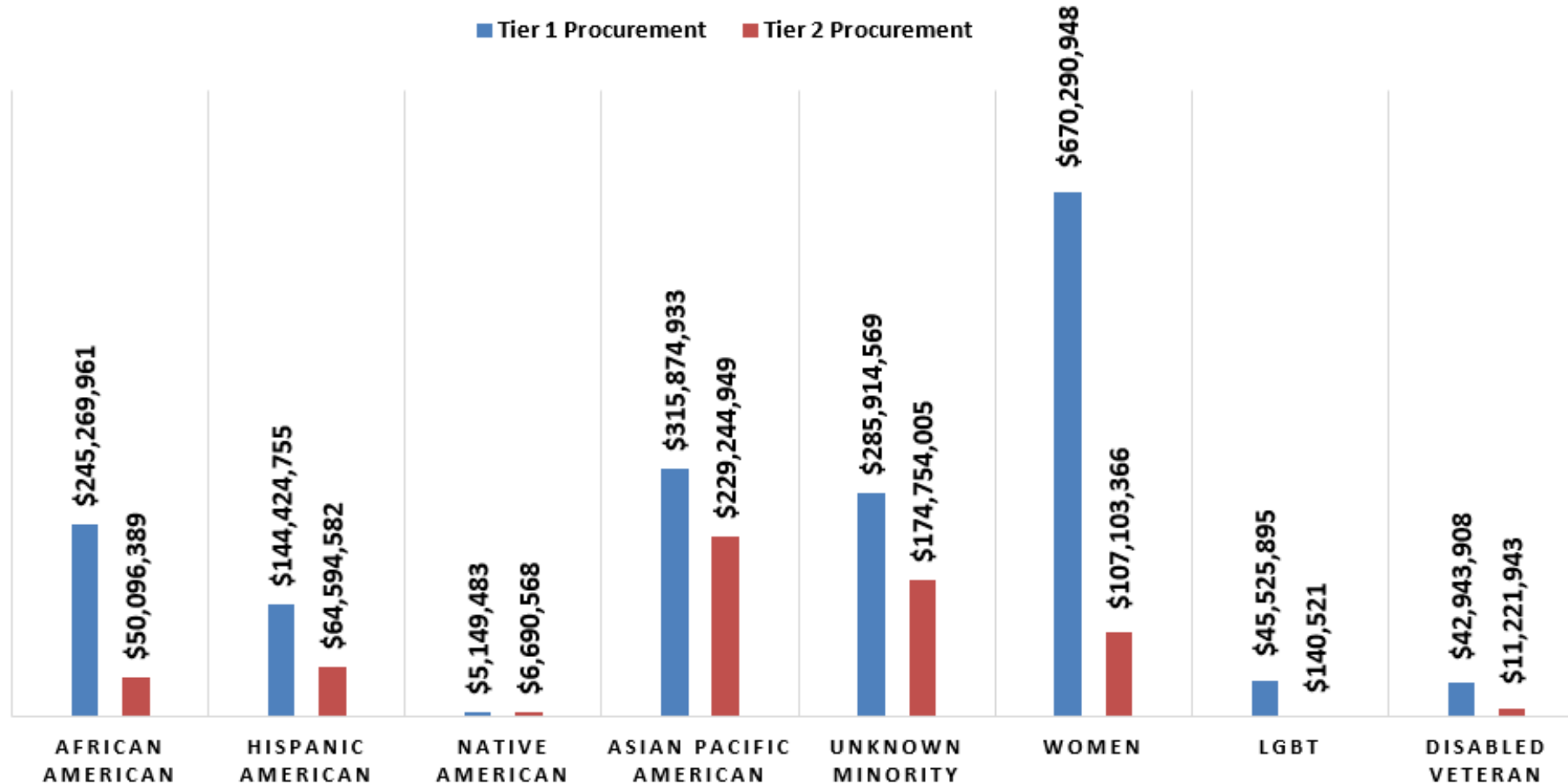
Total Diverse Procurement

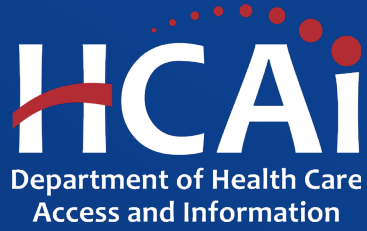

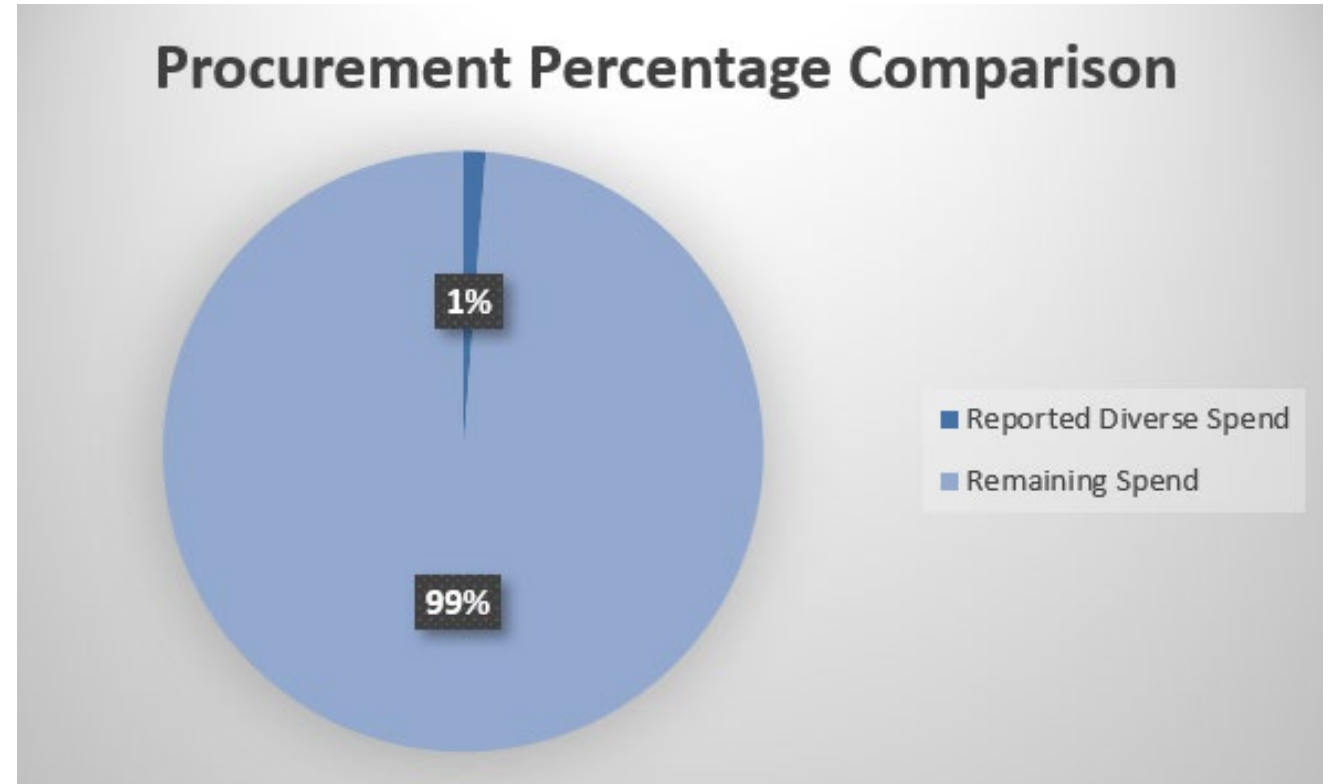

- Hospitals are encouraged to submit a report if procurement was done at the system or regional-level.

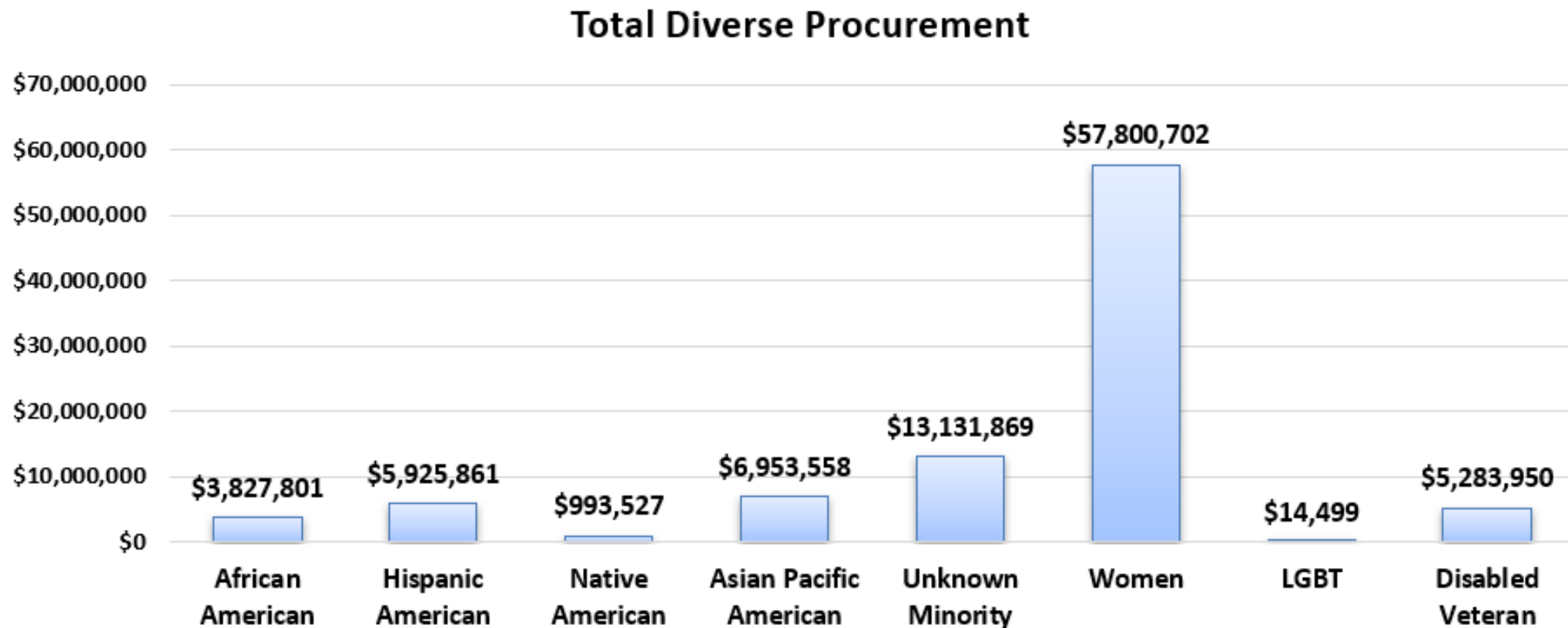

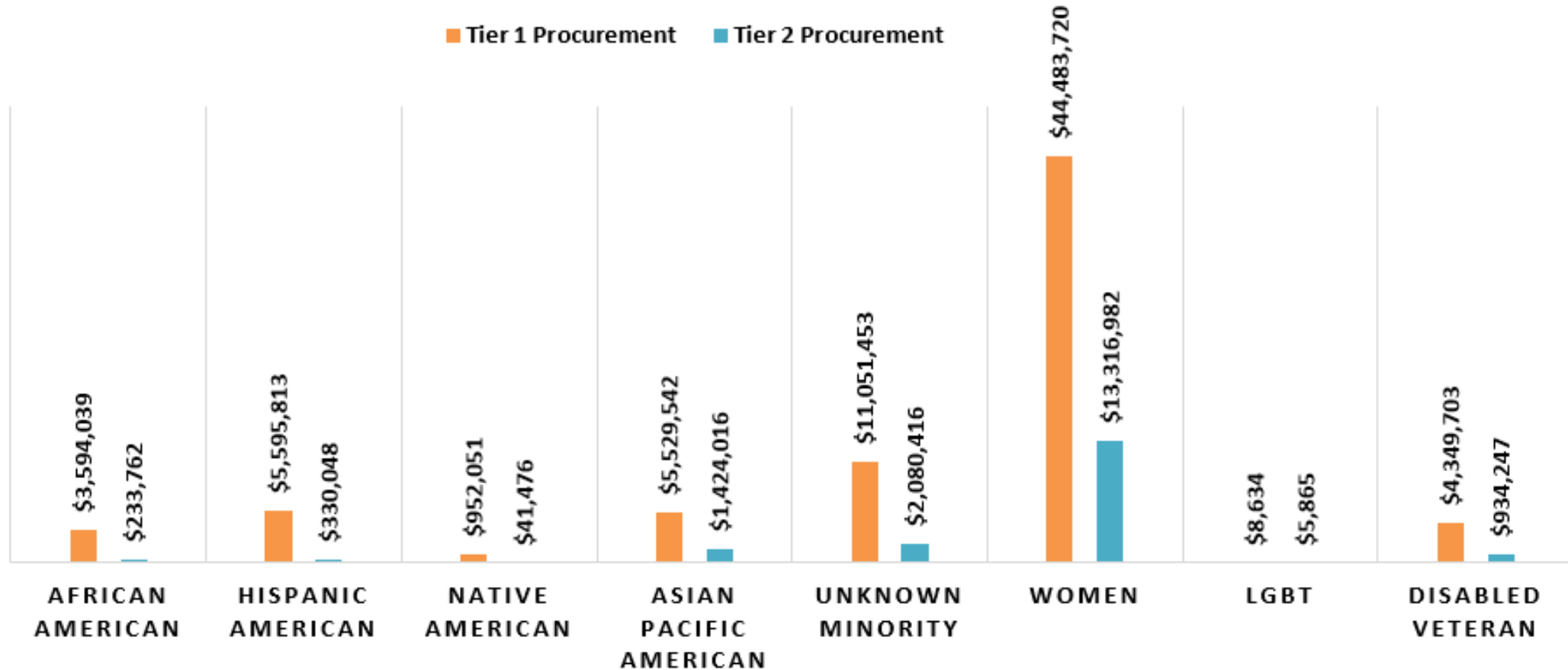

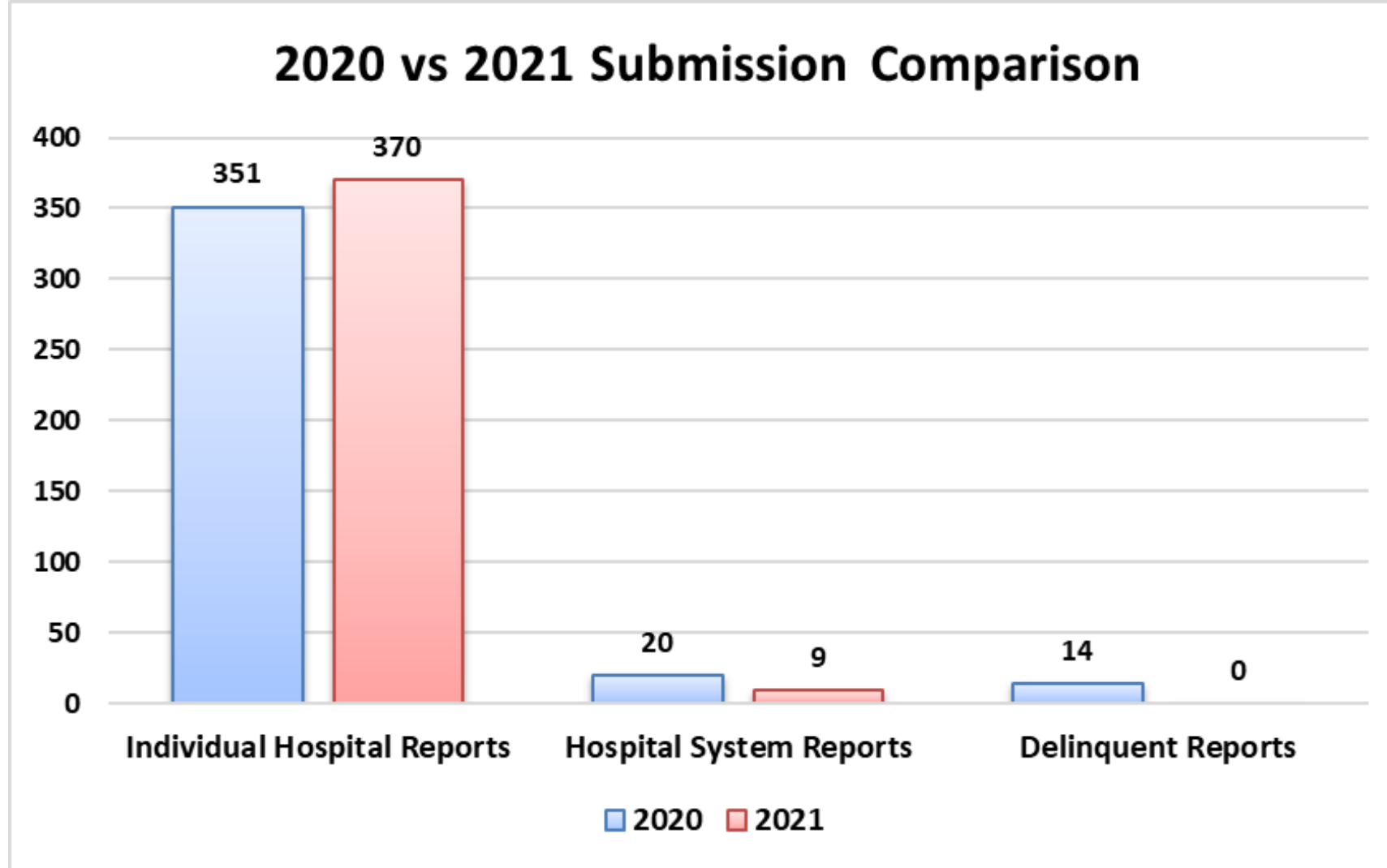
Reviewed 351 Hospital reports from 2020 using the following criteria to be include in this analysis.

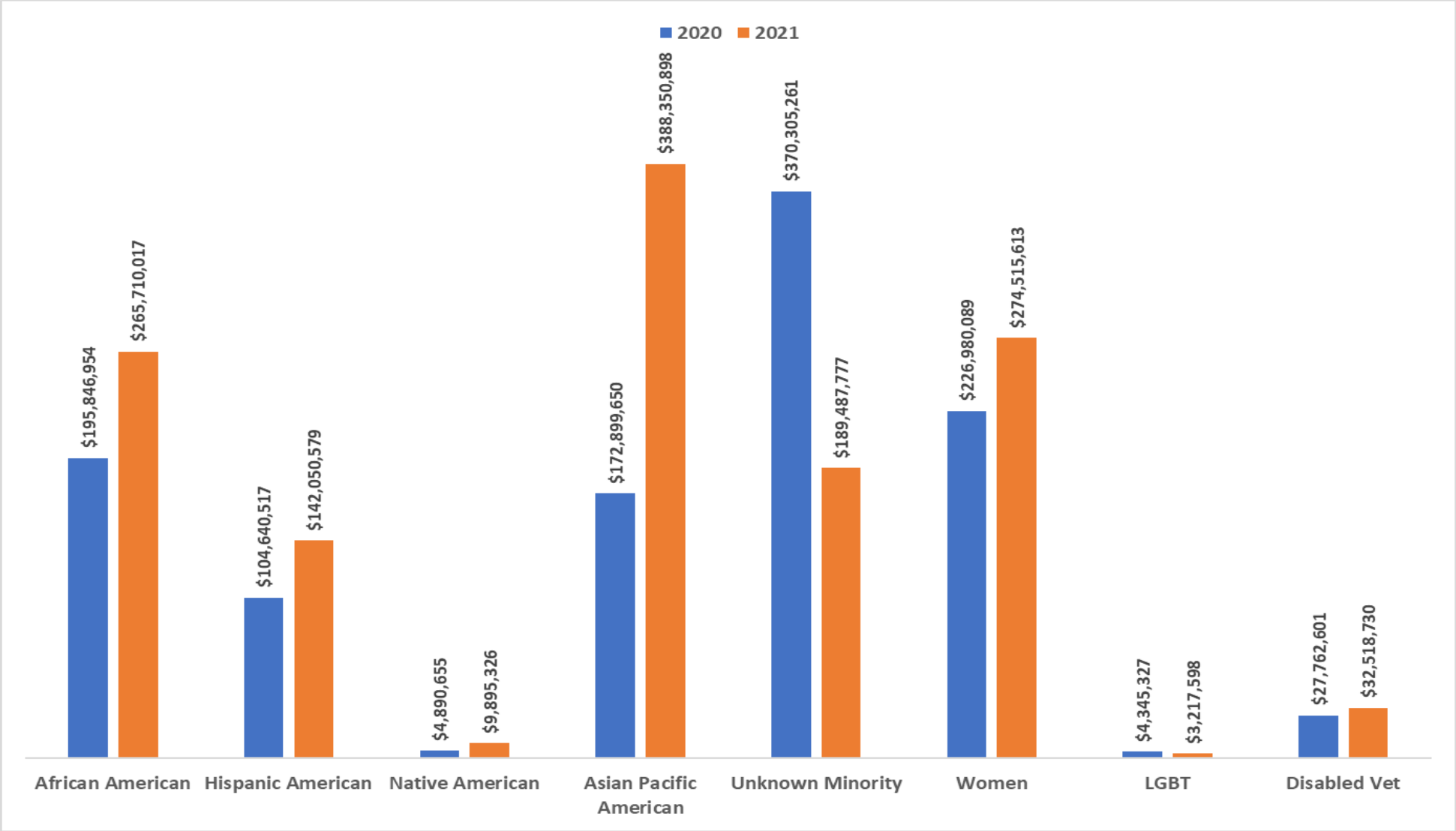
