ResCare is a Kentucky corporation that, itself and through the ResCare Subsidiaries, operates intermediate care facilities (“ICFs/IDD”), focusing on services for individuals with intellectual and developmental disabilities (“IDD”) and other behaviorally complex populations with multiple chronic conditions and co-morbidities. ResCare, itself and through the ResCare Subsidiaries, also provides home and community-based health services (“HCBS”) for individuals with IDD through the HCBS Medicaid waiver program, including residential services in community group homes (“Waiver Group Home” or “WGH”). ResCare is a wholly-owned subsidiary of BrightSpring Health Services, Inc., a Delaware corporation.</p> <p>As further described in this notice, the Transaction involves National Mentor Holdings, Inc.’s (“Buyer”) acquisition of the ResCare Subsidiaries from ResCare that provide Waiver Group Home services and operate licensed and certified ICFs/IDD. Buyer will also acquire certain equities of entities operating outside of California owned by ResCare Residential Services Central, LLC and SpringHealth Integrated Care, Inc. The Transaction also includes Buyer’s acquisition of certain assets from the Asset Sellers (as defined below) that primarily relate to ResCare’s Community Living business, except for ResCare’s children’s foster care services line.</p> <p>ResCare’s primary business lines in California include ICFs/IDD and WGH.</p> <ul style="list-style-type: none"> • ResCare’s ICFs/IDD are targeted at individuals with IDD. Facilities are typically supported group homes of four to eight individuals. At its ICFs/IDD, ResCare

strives to promote individual independence and safety while also providing 24/7 care, which may include nursing care and intensive medical care, as well as opportunities for group development and social interaction.

- **ResCare’s WGH** offer individuals with IDD a more personal and home-like atmosphere. With no more than three to six individuals in a house, each resident receives their own bedroom. WGH are staffed 24/7, meals are served in common areas to give residents opportunities for social interaction and camaraderie, and residents share household responsibilities, including but not limited to cooking, cleaning, and shopping. WGH are funded solely by HCBS Medicaid waiver programs.
- ResCare also offers several categories of support and ancillary services related to its HCBS programs. These include Adult Day Services, Periodic Care Services, Intensive Residential Treatment Services, Residential Youth Services, Rest Assured Remote Monitoring and Case Management Services.

Notwithstanding ResCare’s various business lines and service offerings and those provider types that are included in the Transaction, the notice to the Office of Health Care Affordability (the “**Office**”) required by Cal. Health & Safety Code § 127507 and Cal. Code Regs. tit. 22, § 97431 et seq. (collectively, the “**Notice Requirements**”) specifically pertains to material change transactions involving “health care entities.” Cal. Health & Safety Code § 127507(c). As applicable to ResCare and the Transaction, that term is defined to include “providers,” and such term is further defined to include “health care facilities” that deliver or furnish health care services and to which persons are admitted for a 24-hour stay or longer. Cal. Health & Safety Code § 127500.2(k); Cal. Health & Safety Code § 1250; Cal. Health & Safety Code § 127500.2(q)(2).

ResCare and the ResCare Subsidiaries operate 86 facilities in California, including 75 ICFs/IDD and 11 WGH. As of January 2025, ResCare employed 1,202 people in California.

- In fiscal year 2024, ResCare’s residential facilities served approximately 15,392 individuals across the country and 620 individuals in California. Within California, 519 of those individuals were in ICFs/IDD, 45 were in WGH, and 57 were in Adult Day Services.
