This Schedule 6 is submitted to the Office of Health Care Affordability with respect to the Material Change Notice filed by Sharon Care Center, LLC ("**Submitter**") in response to 22 C.C.R. § 97438(b)(5), requiring Submitter to provide the following: "Description of transaction, which shall include the following: (A) The goals of the transaction; (B) A summary of terms of the transaction; (C) A statement of why the transaction is necessary or desirable; (D) General public impact or benefits of the transaction, including quality and equity measures and impacts; (E) Narrative description of the expected competitive impacts of the transaction; and (F) Description of any actions or activities to mitigate any potential adverse impacts of the transaction on the public."

(A) The Goals of the transaction:

The goal of this transaction was to transfer the ownership of Submitter from Summit to BQ Opco in order to ensure the continued operation of the Facility by an affiliate of an experienced SNF operator, without any disruptions to the care of the Facility's resident.

The related lease assignment and sublease termination allows for the Submitter to retain its possessory interest in the real estate and to directly hold that leasehold interest (rather than through the sublandlord).

(B) A summary of the terms of the transaction:

As set forth in more particular detail in the attached Membership Interest Transfer Agreement, dated January 30, 2024, upon the closing of this transaction on October 1, 2024, Summit sold to BQ Opco all of the issued and outstanding membership interest in Submitter, in exchange for the Closing Purchase Price as that term is described therein and the Buyer's assumption of all of the Seller's "Business Liabilities" respecting the Submitter entity. Furthermore, to allow for Submitter to directly hold the leasehold interest (rather than through a sublease with LRG), Submitter and LRG have terminated the sublease for the Facility's property and LRG has assigned its lease to Submitter, such that Submitter directly leases the Facility's property.

(C) A statement of why the transaction is necessary or desirable:

California heavily regulates the reputability and responsibility of SNF operators, as well as limits the number of affiliated SNFs they may own (see below). As evidenced by BQ Opco's affiliates' long-term experience in the operation of SNFs in California and approval of the licensure application to CDPH approving of BQ Opco as the indirect owner of Submitter, the transaction ensures the Facility continues to be owned and operated by a licensee with a proven track record of quality services. The transaction also allows the Facility and its residents to benefit from BQ Opco's and its affiliates' localized operations and strong relationships with regulators, payers, and communities locally and in California.

(D) General public impact or benefits of the transaction, including quality and equity measures and impacts:

We believe this transaction is beneficial to the public, and allows the Facility and its residents to benefit from BQ Opco's and its affiliates' expertise and local relationships. BQ Opco and its affiliates are now able to leverage their localized operations and relationships with California regulators, payers, and the community to coordinate SNF services efficiently and to better promote competition with other SNF operators in the local market.

(E) Narrative description of the expected competitive impacts of the transaction:

Pursuant to the Skilled Nursing Facility Ownership and Management Reform Act of 2022 ("the Act"), CDPH automatically denies applications for a SNF where the applicant owns, operates, or manages 10 percent or more of the licensed skilled nursing facilities in California, unless CDPH in its discretion concludes that the interests of resident health and safety requires that an exception is warranted. Health & Safety Code 1253.3(g)(12)(D). On the statewide level, this transaction does not lessen competition or lead to any market consolidation in SNF services beyond what is permissible under the Act.

On the local level, based on publicly available information, there are 376 SNFs in Los Angeles County, most of which are owned and operated by entities that are unaffiliated and unrelated to any of the parties to this transaction. Prior to and following the closing of this transaction and the Alexandria Transaction, BQ Opco and its affiliates own 18 of the 376 SNFs in Los Angeles County. This transaction ensures Submitter will have sufficient resources, expertise, and local connections to compete with local SNF chains, without giving any party to the transaction dominant market power over SNF services in the local market. Rather, we think this transaction ultimately increases competition in Los Angeles County.

(F) Description of any actions or activities to mitigate any potential adverse impacts of the transaction on the public:

There are no anticipated adverse impacts on the public resulting from this transaction. By ensuring that an affiliate of experienced SNF operators took over operation of the Facility, this transaction is structured to ensure that quality skilled nursing services remain available to serve residents living within the community the Facility serves.

For example, if Submitter sold its operations to ABC Corp., an entity unaffiliated with Submitter, and then ABC Corp. subsequently entered into a transaction with XYZ Corp., then Submitter would not have access to any non-publicly available information pertaining to such subsequent transaction.
