	AmSurg Holdings, LLC ("AmSurg Holdings") is a wholly-owned subsidiary and holding company of Ambulatory TopCo, LLC ("AMSURG"). AmSurg Holdings is governed pursuant to its single member, Delaware Limited Liability Company Agreement (see Section 12, Folder 9, "LLC Operating Agreement – AmSurg Holdings, LLC (Executed)(16538909.1))." Management of AmSurg Holdings is vested in the sole member who has authority to control, manage, and exercise all powers of AmSurg Holdings. AmSurg Holdings maintains no financials and consolidated financials for Ambulatory Intermediate Co 2, LLC are provided. Ambulatory Intermediate Co 2, LLC was created in 2023 and these are all

the financial statements for Ambulatory Intermediate Co 2, LLC. (See Section 12, Folder 8, "Ambulatory Intermediate Co 2 LLC Financials - 12.31.24 (FINAL)(106396239.1)."

AMSURG is a nationally recognized leader in the strategic and operational management of over 250 ambulatory surgery centers ("ASCs") across 34 states (including 25 ASCs in California) that deliver high quality, high value, same-day surgical services with a superior patient experience. AMSURG combines technology, data analytics, patient engagement, and quality reporting that results in optimal outcomes for patients. As a result, AMSURG provides health care value, improves patient experience, and saves lives.

AMSURG ASCs offer gastroenterology, ophthalmology, orthopedics, urology, and other multi-specialty surgical services.

AMSURG partners with physicians and hospitals/health systems to manage ASCs that perform to the highest standards of patient care and quality. Under AMSURG's traditional physician partnership model, the ASC is co-owned with local surgeons and is operated by consensus between the surgeons and AMSURG. AMSURG also partners with hospitals and health systems, creating a mutually beneficial three-way joint venture partnership.

	AMSURG currently performs services in Alameda, Fresno, Los Angeles, Marin, San Bernardino, San Diego, San Luis Obispo, Sacramento, San Mateo, Santa Clara, and Shasta counties. With the Proposed Transaction, AMSURG intends to maintain Euclid's existing locations and implement AMSURG's proven model of physician-led joint ventures and governance ensuring that

physicians are empowered to share the

delivery of care in their communities.

The AMSURG ambulatory surgical centers (ASCs) operating in California primarily offer gastrointestinal services. With the Proposed Transaction, from EEC's two locations in San Diego County, AMSURG will offer the full range of endoscopy procedures (including upper and lower diagnostic and therapeutic endoscopy procedures) and colonoscopies.

AMSURG's California ASCs have collectively served approximately 64,000 patients. The centers provide care to a demographically diverse patient population, including individuals of all ages (from infants to the elderly), genders, racial and ethnic backgrounds, preferred language, and disability status. While many patients do not provide information regarding their demographics, the majority of patients providing such information identify as either non-Hispanic or Hispanic/Latino and the centers also serve patients identifying as American Indian or Alaska Native, Asian, Black or African American, and Native Hawaiian or other Pacific Islander. The ASCs maintain a broad payor mix, encompassing commercial insurance. Medicare and Medicare Advantage plans, Medicaid and managed Medicaid programs, TRICARE, and self-pay arrangements. There will be no posttransaction changes to the number and type of patients served by AMSURG.

AMSURG has not conducted any community needs assessments and does not formally maintain any charity care or community benefit programs. However, at many of AMSURG's California ASCs, patients may apply for financial assistance on a case-by-case basis. Under AMSURG's ownership EEC will be operated and managed in a manner that (1) provides access to patient care services based on medical necessity, without regard to the patient demographics or ability to pay, (2) provides access to patient care services to individuals covered by Medicare, Medicaid, and other state or federal health care programs, and (3) provides

financial assistance on a case-by-case basis. The AMSURG California ASCs do accept Medi-Cal and Medicare eligible patients. At EEC, AMSURG intends to continue accepting Medi-Cal and Medicare patients. Acquisition of Ownership Interest in Folsom Sierra Endoscopy Center: On September 8, 2018, AMSURG acquired an ownership interest in Folsom CA GI, d/b/a Folsom Sierra Endoscopy Center, an ambulatory surgery center specializing in gastroenterology located at 1671 Creekside Drive, Suite 100, Folsom, CA. On March 22, 2024, AMSURG exercised a buy-up option and purchased additional ownership interest in Folsom Sierra **Endoscopy Center. The parties anticipate that this transaction will close in the first or second quarter of 2026. Second, pursuant to a pending membership interest purchase agreement, a wholly-owned subsidiary of AmSurg Holdings, LLC intends to sell its majority interest in a California ASC

to certain California-based physicians and an affiliated California-based management services organization. The terms and conditions of the proposed transaction are being negotiated and the parties anticipate filing a MCN with OHCA on or before
December 31, 2025.

Section 6

Description of Transaction

i. The goals of the transaction:

AmSurg Holdings, LLC ("AmSurg Holdings") is a wholly-owned subsidiary and holding company of Ambulatory TopCo, LLC ("AMSURG"). The goal/purpose of the transaction is to gain access to AMSURG's physician partnership model in order to leverage AMSURG's expertise, technology, data analytics, patient engagement, and quality reporting to enable EEC's physicians to more efficiently provide high quality surgical services to EEC's patients and focus more on patient care instead of the nonclinical administrative aspects of the endoscopy centers. See attached document Section 10_Additional Entities for a description of AMSURG and its business.

ii. A summary of the terms of the transaction:

As set forth in more particular detail in the unsigned Membership Interest Purchase Agreement ("Purchase Agreement"), shortly before the closing of the purchase and sale transaction EEC will convert from a California limited partnership to a California limited liability company. At the closing of this transaction, the owners of ECC will collectively sell 51% of the issued and outstanding membership interests in EEC to AmSurg Holdings in exchange for the Purchase Price, as that term is defined in the Purchase Agreement. Under the operating agreement of EEC, as a member AmSurg Holdings will provide comprehensive management and administrative services to EEC.

iii. A statement of why the transaction is necessary or desirable:

The proposed transaction is necessary as EEC is seeking improved management and administrative support and expertise to continue providing high quality care in the community and attract additional physicians to the market in order to expand access to high quality endoscopy services within the communities which the endoscopy centers are located.

iv. General public impact or benefits of the transaction, including quality and equity measures and impacts:

The proposed transaction will not have any negative impact on the public. AmSurg Holding's acquisition of a 51% interest of EEC and AMSURG's provision of administrative and management related services will relieve EEC's physicians from day-to-day administrative and nonclinical duties and obligations and allow the physicians to focus on providing high quality endoscopy services for all patient types, while simultaneously increasing patient access to a comprehensive list of endoscopy services at EEC's two ASC locations. Following the closing of the proposed transaction there will be no change in the services, leadership or clinical or administrative staff at EEC.

v. Narrative description of the expected competitive impacts of the transaction:

The proposed transaction is not expected to have any negative impact on competition. The EEC providers will continue to provide professional services in the communities where EEC operates its two endoscopy centers, and will now have additional time to focus on patient care following EEC's outsourcing of much of its day-to-day non-clinical management obligations.

vi. Description of any actions or activities to mitigate any potential adverse impacts of the transaction on the public:

The parties do not anticipate the transaction to cause any adverse impacts on the public.

(i) Post-transaction, there will be no changes to the ownership, governance, or operational structure of AMSURG. Upon closing the transaction, EEC will be a California limited liability, 51% of which will be owned by AmSurg, Holdings, and 49% owned by the four current limited partners of EEC. EEC will be managed by a board of managers consisting of four managers, two of which will be appointed by AmSurg Holdings and two of which will be appointed by the members holding the other 49% of EEC. Post-transaction, most of the non-clinical administrative and management related duties will be handled by AMSURG.

There will be no post-transaction changes in the entities owning and holding applicable California licenses and permits, which will continue to be held by EEC, and no change in the services, leadership, or clinical or administrative staff of EEC. Further, there will be no post-transaction changes to any applicable city or county contracts regarding the provision of health care services. Following the closing of the transaction AMSURG intends to maintain the EEC's endoscopy centers' current operations in all material respects. As a consequence, the parties believe that the proposed transaction will not impact business line concentration or competition in the California market, and there is not expected to be any negative impact upon the availability, accessibility or quality of health care services. The transaction is not expected to result in the lessening of competition, creation of a monopoly or entrenchment or extension of a dominant market position of any health care entity.

(ii) AMSURG currently employs approximately 820 personnel at its California ASCs. As a result of this transaction, AMSURG anticipates no changes to its California ASC employee staffing levels, job security, retraining policies, wages, benefits, working conditions, and/or employment protections. Further, AMSURG does not anticipate any changes to EEC's current staffing levels, job security, or retraining policies or any negative impact on their wages, benefits, working conditions, or employment protections.

- (iii) There will be no post-transaction changes to any applicable city or county contracts held by AMSURG's ASCs regarding the provision of health care services.
- (iv) Within 20 miles of each of AMSURG's ASC in the eleven California counties where AMSURG provides services, there are at least 120 other outpatient surgery centers providing comparable services operated by California health systems, hospitals, and independent and national corporate ASC chains. Certain ASCs only offer one line of health care services, while other ASC are multi-specialty and offer different lines of health care services.

<u>Counties Where Services Are Currently Performed and Any Post-Transaction Changes</u> Thereto

AMSURG currently performs services in Alameda, Fresno, Los Angeles, Marin, San Bernardino, San Diego, San Luis Obispo, Sacramento, San Mateo, Santa Clara, and Shasta counties. With the Proposed Transaction, AMSURG intends to maintain Euclid's existing locations and implement AMSURG's proven model of physician-led joint ventures and governance ensuring that physicians are empowered to share the delivery of care in their communities.

Levels And Type Of Health Care Services Currently Offered

The AMSURG ambulatory surgical centers (ASCs) operating in California primarily offer gastrointestinal services. With the Proposed Transaction, from EEC's two locations in San Diego County, AMSURG will offer the full range of endoscopy procedures (including upper and lower diagnostic and therapeutic endoscopy procedures) and colonoscopies.

<u>Summary of the Number and Type Of Patients Currently Served and Any Post-Transaction Changes Thereto</u>

AMSURG's California ASCs have collectively served approximately 64,000 patients. The centers provide care to a demographically diverse patient population, including individuals of all ages (from infants to the elderly), genders, racial and ethnic backgrounds, preferred language, and

disability status. While many patients do not provide information regarding their demographics, the majority of patients providing such information identify as either non-Hispanic or Hispanic/Latino and the centers also serve patients identifying as American Indian or Alaska Native, Asian, Black or African American, and Native Hawaiian or other Pacific Islander. The ASCs maintain a broad payor mix, encompassing commercial insurance, Medicare and Medicare Advantage plans, Medicaid and managed Medicaid programs, TRICARE, and self-pay arrangements. There will be no post-transaction changes to the number and type of patients served by AMSURG.

<u>Current Community Needs Assessments, Charity Care, and Community Benefit Programs, And Any Post-Transaction Changes Thereto</u>

AMSURG has not conducted any community needs assessments and does not formally maintain any charity care or community benefit programs. However, at many of AMSURG's California ASCs, patients may apply for financial assistance on a case-by-case basis.

Under AMSURG's ownership EEC will be operated and managed in a manner that (1) provides access to patient care services based on medical necessity, without regard to the patient's age, race, color, creed, ethnicity, religion, national origin, marital status, sex, sexual orientation, gender identity or expression, disability, veteran or military status, payor source, or ability to pay, (2) provides access to patient care services to individuals covered by Medicare, Medicaid, and other state or federal health care programs, and (3) provides financial assistance on a case-by-case basis.

Yes, the AMSURG California ASCs do accept Medi-Cal and Medicare eligible patients. At EEC, AMSURG intends to continue accepting Medi-Cal and Medicare patients.

Acquisition of Ownership Interest in Spinal Diagnostics and Treatment Center: On March 1, 2017, AMSURG acquired an ownership interest in Daly City CA Pain, d/b/a Spinal Diagnostics and Treatment Center, a pain management center located at 901 Campus Dr. Ste 310. Daly City, CA. The Spinal Diagnostics and Treatment Center was closed and a Certificate of Cancellation for the LLC was filed on November 29, 2018 with the California Secretary of State.

Acquisition of Ownership Interest in Folsom Sierra Endoscopy Center: On September 8, 2018, AMSURG acquired an ownership interest in Folsom CA GI, d/b/a Folsom Sierra Endoscopy Center, an ambulatory surgery center specializing in gastroenterology located at 1671 Creekside Drive, Suite 100, Folsom, CA. On March 22, 2024, AMSURG exercised a buy-up option and purchased additional ownership interest in Folsom Sierra Endoscopy Center.
