Description of the Transaction	<p>InformDx, Fulgent Therapeutics LLC, and Bako Pathology LP, Bako Pathology Holdings Corp., BPA Holding Corp., Dermatopathology Experts, LLC, Bakotic Pathology Associates, L.L.C., Podceuticals L.L.C., and GBRL Consulting, LLC (collectively, Bako) have entered into definitive agreements pursuant to which, among other things, InformDx will (a) purchase all of the issued and outstanding equity interests of Dermatopathology Experts, LLC in exchange for the purchase price of \$12.5 million subject to price adjustments, as set forth in the Purchase and Sale Agreement (PSA), and (b) purchase substantially all of the assets and certain specified liabilities related to the diagnostic and therapeutic services of Bako Pathology Holdings Corp. and its subsidiaries in exchange for the purchase price of \$43 million subject to price adjustments, as set forth in the Asset Purchase Agreement (APA) (Bako Assets) (collectively, the Proposed Transaction). As a result of this strategic Proposed Transaction, Dermatopathology Experts, LLC will operate as a wholly owned subsidiary of InformDx, and the Bako Assets will be incorporated into the existing operations of InformDx or one of its subsidiaries.</p>

	<p>Bako does not have a physical presence in California and its operations are limited to the acceptance of specimens from California patients which are processed by a non-California clinical laboratory. The Proposed Transaction will have minimal impact upon California or California patients. In the immediate term, California residents will have no changes to their laboratory providers as a result of the Proposed Transaction. The Proposed Transaction will allow InformDx to enhance its laboratory services by broadening product and service offerings, while expanding its national presence through a diverse client base and network of expert pathologists. Inform Diagnostics, Inc. (InformDx) is nationally accredited anatomic pathology laboratory headquartered in Texas, specializing in dermatopathology, hematopathology, breast, urologic, and molecular diagnostics. InformDx emphasizes stringent quality assurance protocols, fellowship-trained pathologists, and advanced laboratory information systems to support timely and accurate diagnostic services. InformDx and its subsidiaries and affiliates operate in California and most other states, with three licensed and CLIA-accredited laboratories in California – Inform Diagnostics, Inc. (Oceanside); Lakewood Pathology Associates, Inc. d/b/a Inform Diagnostics (Anaheim); and; Cohen Dermatopathology, PC d/b/a Inform Diagnostics (Palm Desert). InformDx also has CLIA certified locations in Arizona, California, Maryland, Massachusetts, New York, Ohio, and Texas.

InformDx is a wholly owned subsidiary of California-headquartered Fulgent Genetics, Inc. and Fulgent Therapeutics LLC (collectively, Fulgent) which is a technology-based company with a well-established (1) laboratory services business and a (2) therapeutic development business. The laboratory services business includes technical laboratory and testing services and professional interpretation of laboratory results by licensed physicians. The therapeutic development business is focused upon developing drug candidates for treating a broad range of cancers utilizing a novel nanoencapsulation and targeted therapy platform designed to improve the therapeutic window and PK profile of new and existing cancer drugs.

InformDx is governed pursuant to a Delaware Certificate of Incorporation (see Section 12\_Folder 9\_Inform Diagnostics, Inc. – Charter.) Management of InformDx is pursuant to a Board of Directors who have authority to control, manage, and exercise all power of InformDx (see Section 12\_Folder 9\_Inform Diagnostics, Inc. – Bylaws). (Note that Caris Diagnostics, Inc. is the predecessor name of InformDx). Neither InformDx nor Fulgent Therapeutics LLC maintain any financials and consolidated financial statements/10-Ks are provided for Fulgent Genetics, Inc. for 2022-2024 (see Section 12\_Folder 8). In that regard, revenues for 2024 were \$283 million, for 2023 \$289 million, and for 2022 \$619 million.

While many client-patients receiving testing do not provide information regarding their demographics, InformDx provides laboratory services to a demographically diverse patient population, including individuals of all ages, genders, racial and ethnic backgrounds, preferred language, and disability status. InformDx supports a broad payor mix, encompassing commercial insurance, Medicare and Medicare Advantage plans, Medicaid and managed Medicaid programs, TRICARE, and self-pay arrangements. Other than expanding product and service offerings as a result of the Proposed Transaction, there will be no post-transaction changes to the number and type of client-patients served by InformDx.
