With Envision Radiology, LLC, Rezolut believes it has found a partner that shares those values and commitments, and that has the financial backing to help Rezolut take the next steps in its growth. Pursuant to an executed Equity Purchase Agreement dated October 9, 2025 ("Agreement") by and among Envision Radiology, LLC ("Purchaser"), Parent and Rezolut, Purchaser shall acquire 100% of the issued and outstanding equity interests of Rezolut from</p>

	<p>the Parent in exchange for the consideration described in the Agreement. Rezolut experienced tremendous growth over the past seven years, expanding its geographic footprint and advancing an operating model centered on employee empowerment, imaging excellence, and innovation.
