Attachment A

Description of Submitting Organization

Southern California Specialty Care, LLC ("Submitter") is a California limited liability company. Submitter is an affiliate of Kindred Hospitals, a nationwide health system of specialty hospitals. Submitter owns and operates the long-term acute care hospital known as Kindred Hospital - La Mirada, located at 14900 E. Imperial Highway, La Mirada, CA 90638. Kindred Hospital - La Mirada is licensed by the California Department of Public Health as a general acute care hospital, certified by Medicare as a long-term acute care hospital, with 118 beds, including 24 rehabilitation beds and 6 intensive care beds. Kindred Hospital – La Mirada is staffed with over 271 employees and provides services including respiratory care, wound care, infectious disease care, medically complex care, intensive care, brain injury and stroke care, cardiac care, kidney care and comprehensive rehabilitation. Kindred-Hospital - La Mirada also offers a six-bed ICU and two negative pressure rooms to accommodate particularly serious conditions. Kindred Hospital - La Mirada served 479 patients in 2024. As a Medicare certified long term acute care hospital, Kindred Hospital - La Mirada typically treats patients who have had a prior stay in an acute care hospital's intensive care unit or who are ventilator dependent. Its patients also have a longer length of stay than traditional acute care hospital patients. Kindred Hospital - La Mirada's profile with the California Department of Health Care Access and Information ("HCAI") can be found here: https://hcai.ca.gov/facility/kindred-hospital-la-mirada/

Submitter is licensed for two additional hospital campuses under the Kindred Hospital – La Mirada hospital license and Medicare certification: Kindred Hospital – San Gabriel Valley and Kindred Hospital – Santa Ana. Kindred Hospital – San Gabriel Valley is located at 845 N. Lark Ellen Ave., West Covina, CA 91791-1069 and is licensed for 76 beds. Kindred Hospital – Santa Ana is located at 1901 College Ave., Santa Ana, CA 92706-2334 and is licensed for 54 beds. Both Kindred Hospital – San Gabriel Valley and Kindred Hospital – Santa Ana provide the following services to patients: respiratory care, wound care, infections disease care, intensive care, brain injury and stroke care, cardiac care, kidney care, medically complex care and comprehensive rehabilitation. Kindred Hospital – Santa Ana employs approximately 244 active employees and Kindred Hospital – Santa Ana employs approximately 189 active employees, who provide the above services to patients. Similarly to Kindred Hospital – La Mirada, patients typically require the services of Kindred Hospital – San Gabriel or Kindred Hospital – Santa Ana when they are in need of a longer hospital stay and are often ventilator dependent or have received services in an acute care hospital's ICU.

Patients come to Kindred Hospitals with serious conditions such as respiratory failure, complex wounds, sepsis, stroke, congestive heart failure, or even a combination of these. Their diagnoses are often complicated by existing health problems like diabetes or COPD. Many of the Kindred Hospital patients have multiple co-morbidities and require treatments such as mechanical ventilators, dialysis, or IV therapy.

Attachment B

Description of the Transaction

- (A) Kindred Hospitals decided to sell certain hospitals subject to this transaction in order to better position itself in the nationwide market. The proceeds of the sale of these hospitals will allow Kindred Hospitals to make investments in other hospitals and service lines that it provides throughout the country. Kindred Hospitals intentionally chose a buyer that is part of an organization with extensive experience operating similar facilities to ensure that the hospitals could continue to maintain materially the same level of operations after the sale of the hospitals.
- (B) The material change transaction described herein involves the sale of assets and real estate related to the operation of three Kindred Hospitals facilities in California, Arizona, and Louisiana. Submitter is party to that certain Asset Purchase Agreement, dated May 12, 2025 (the "APA"), by and between Submitter, CHG Hospital Tucson, LLC, CHG Hospital West Monroe, LLC, (collectively, "Sellers"), Post Acute Development 1, LLC, Post Acute Development 2, LLC, Post Acute Development 3, LLC, Vista Specialty Hospital of California, LLC, Vista Specialty Hospital of West Monroe, LLC, and Vista Specialty Hospital of Tucson, LLC (collectively, "Buyers") (the "Proposed Transaction"). The Proposed Transaction involves Buyers purchasing from Sellers substantially all of the assets involved in the operation of: (1) Kindred Hospital – La Mirada; (2) Cornerstone Hospital West Monroe, a long specialty acute care hospital located in West Monroe, Louisiana; and (3) Cornerstone Specialty Hospitals Southeast Arizona, a specialty acute care hospital located in Tucson Arizona (collectively, the "Transferred Facilities"), as well as the real estate on which the Transferred Facilities are located. The purchase price under the Proposed Transaction is \$10,600,000. The APA requires Buyers to offer employment to substantially all of Seller's current employees that provide services at the Transferred Facilities, and that such offers of employment be substantially consistent with those being provided by the Sellers immediately prior to the closing of the Proposed Transaction.
- (C) Kindred Hospitals is seeking to divest the Transferred Facilities in order to make strategic investments in other operations throughout the country and chose a buyer with the ability to continue the services currently provided at the Transferred Facilities. The Proposed Transaction will allow for the continued provision of specialty hospital services at the Transferred Facilities with the support of investments by Buyers. In addition, Buyers and their affiliates currently do not have operations in California, so their acquisition of Kindred Hospital La Mirada would result in a new competitor entering into the California specialty hospital market.
- (D) The parties do not anticipate any potential adverse impacts on the public as a result of the transaction. The transaction is expected to benefit the public by maintaining access to critical long term acute care hospital services currently being provided by Kindred Hospitals at the Transferred Facilities. As discussed above, Kindred Hospitals is seeking to divest the Transferred Facilities in order to make strategic investments in other operations throughout the country, but the Proposed Transaction will allow for continued access to health care services currently provided at the Transferred Facilities. Kindred chose a buyer that is part of an organization with extensive experience operating similar facilities in order to ensure the continued operation of the Transferred Facilities at substantially the same level of operation. In fact, Submitter understands that Vista Specialty Hospital of California, LLC plans to invest approximately \$5 million in the facility and equipment of Kindred Hospital La Mirada. Further, consummation of the transaction will allow for the continued above, Vista Specialty Hospital of California, LLC has contractually committed to offering employment to substantially all of Seller's current employees on terms substantially consistent with those currently offered by Submitter.

- (E) The parties do not expect the Proposed Transaction to result in negative competitive impacts in the market currently served by Kindred Hospital – La Mirada. Buyers and their affiliates currently do not have operations in California, so their acquisition of Kindred Hospital – La Mirada would result in a new competitor entering into the California specialty hospital market.
- (F) Submitter does not anticipate any material changes to the operations of Kindred Hospital La Mirada as a result of the Proposed Transaction. Submitter understands that Buyers will continue to operate the hospital in materially the same way as operated by Submitter pre-closing, including continuing to provide services to Medicare and Medi-Cal beneficiaries in the communities currently served by Kindred Hospital La Mirada. In addition, as described above, Buyers have contractually agreed to offer employment to substantially all of Seller's current employees that provide services at the Kindred Hospital La Mirada, and such offers of employment must be substantially consistent with those being provided by the Sellers immediately prior to the closing of the Proposed Transaction.

Attachment E

Additional Details Regarding Changes to Staffing at Kindred Hospital – La Mirada

The Purchase Agreement requires Vista Specialty Hospital of California, LLC ("Vista") to offer employment to substantially all of Seller's employees providing services at Kindred Hospital – La Mirada in Vista's sole discretion. Seller will cooperate with Vista in identifying such employees and will be informed of the status of Vista's employee onboarding process prior to closing. In Seller's view, Vista's failure to satisfy its contractual obligations regarding employee onboarding under the Purchase Agreement may be cited as grounds for Seller to terminate the Purchase Agreement for cause.

Vista expects to hire the majority of the employees with the exception of those managers who are being retained by seller and those employees who desire to work at one of seller's other locations. Vista Specialty Hospital of California, LLC will hire new employees to fill any gaps left by such managers and employees. Vista plans to begin the hiring process 60 days prior to the anticipated closing date of 10/1/2025. Vista has already held onsite meetings with management and employee forums, and has a robust response form employees who desire to remain at the facility.

Further, Vista expects that the improvements it has planned will encourage employee retention. Post-transaction, Vista will implement a new electronic medical records system which is more user-friendly and efficient than the current system. In addition, a new human resources system will allow for online scheduling and completion of work-related documents. In addition, Vista will be making capital improvements, including updating equipment and making improvements to the facility.

The content of current policies will remain substantially the same. All employees will be trained and educated in any specific changes.
