Evaluation Criteria 1.1, 1.2, and 1.3: Scoring Methodology

- Application Criteria:
 - Percent and number of clinical training sites in medically underserved areas
 - Percent and number of underrepresented minority graduates and/or economically disadvantaged graduates
 - Percent and number of graduates/students in medically underserved areas
- Scoring Methodology Part 1: Predetermined point system
- Scoring Methodology Part 2: Placement in a normal distribution

Section II.1: Primary Care Continuity Clinic Hours

- Application Criteria:
 - Do your non-first year residents spend at least an average of 8 hours per week at a primary care continuity clinic?
- Scoring Methodology:
 - Yes = 10 points
 - No = 0 points

Section II.2: Primary Care Ambulatory Care Settings

- Application Criteria:
 - Percent and number of graduates in primary care ambulatory settings five years post residency
- Scoring Methodology Part 1: Predetermined point system
- Scoring Methodology Part 2: Placement in a normal distribution

Section II.3: Underrepresented Minority Residents

- Application Criteria:
 - Percent and number of underrepresented minority residents
- Scoring Methodology Part 1: Predetermined point system

Percentage	Points
1-33%	0
34-50%	1
51-67%	3
68-100%	5

Scoring Methodology Part 2: Predetermined point system

Number	Points
1-8	0
9-12	1
13-16	3
17-20	5

Score for Part 1 (percentages) 58% = 3 points

Score for Part 2 (numbers) 17 = 5 points

Section II.4: Payer Mix

- Application Criteria:
 - Describe the training sites payer mix (up to three continuity clinics)
- Scoring Methodology:
 - Step 1 averages the payer mix for the three most advantageous continuity clinics reported
 - Step 2 assigns points to percentages based on the table below

Percentage	Points
0-49%-Combination of Medi-Cal, Indigent, Medi-Cal/ Medicare, Uninsured, and Other Payers	0
50-74%-Combination of Medi-Cal, Indigent, Medi-Cal/ Medicare, Uninsured, and Other Payers	10
75-100%-Combination of Medi-Cal, Indigent, Medi-Cal/ Medicare, Uninsured, and Other Payers	20

Budget Overview

■ FY 2019-20 General Fund Budget Bill Provisions

- Up to:
 - \$18,668,000 to fund grant awards for existing PCR slots
 - \$5,667,000 to fund PCR slots for existing teaching health centers
 - \$3,333,000 to fund new PCR slots at existing residency programs (expansion)
 - \$3,333,000 to fund newly accredited PCR programs.
 - Unspent amounts, as of June 30, 2020, may be redirected to fund expansion slots if newly accredited PCR programs have not been established
- Encumbrance or expenditure until June 30, 2023 (six years to award funds)

- Slots Requested: 30
- Total Requested: \$5,100,000
- All programs met the 50% scoring threshold

- Award Amount: \$5,100,000

- 72 Programs
 - 47 Family Medicine programs
 - 10 Internal Medicine programs
 - 7 Obstetrics and Gynecology programs
 - 8 Pediatric programs
- Total Slots Requested: 335
- Total Requested: \$41,875,000
- 62 programs met the 50% scoring threshold

Existing PCR Slots Awards

- Total Preliminary Number of Funded Programs: 62
 - 41 Family Medicine programs
 - 8 Internal Medicine programs
 - 6 Obstetrics and Gynecology programs
 - 7 Pediatric programs
- Total Preliminary Number of Slots Funded: 142
- Total Preliminary Award Amount: \$17,750,000
- FY 2018-19 Roll-over: \$2,836,000

New Programs Awards

- 3 New Programs awarded in FY 2017-18:
 - Did not receive ACGME accreditation.
 - Are reapplying for funding in FY 2018-19.
 - \$500,000 per program (\$1,500,000) goes back to the Data Fund.
- 8 New Programs applied in FY 2018-19
 - 4 Family Medicine programs
 - 3 Internal Medicine programs
 - 1 Obstetrics and Gynecology program
- Total Requested: \$6,400,000
- 7 programs met the 50% scoring threshold.
 - The applicant that did not meet the scoring threshold:
 - Failed to submit a required attachment.
 - The review panel expressed reservations about the overall application.

New Programs Awards

- Number of Funded Programs: 7
 - 3 Family Medicine programs
 - 3 Internal Medicine programs
 - 1 Obstetrics and Gynecology program
- Award Amount: \$5,600,000
- Insufficient funds available to award all eligible applicants
 - \$2,267,000 needed to fund all applicants at \$800,000 per program
 - \$2,581,000 in Data Fund (PCR) money available

Expansion Slots Awards

- 4 Programs
 - 2 Family Medicine programs
 - 1 Internal Medicine program
 - 1 Obstetrics and Gynecology program
- Total Slots Requested: 8
- 2 programs expanded by 3 slots qualifying them for \$900,000 in funding; this exceeds the \$800,000 maximum award for New Programs
- Total Requested: \$2,400,000
- 3 programs met the 50% scoring threshold

Expansion Slots Awards

- Total Preliminary Number of Funded Programs: 3
 - 2 Family Medicine programs
 - 1 Internal Medicine program
- Total Preliminary Award Amount: \$2,100,000
- FY 2018-19 Roll-Over: \$2,616,000
