2017 Inpatient Data Element Changes Are You Ready?

January 1, 2017, will be an important date for MIRCal reporting. As noted in issues #41, #42, and #44, inpatient data requirements will change for several data elements beginning with the January 1 – June 30, 2017, data report period. These changes were approved in regulation in October 2015 and were made in an effort to more closely align MIRCal reporting with the 837 Health Care Service Data Reporting Guide. The new requirements only affect inpatient reporting. If you would like to review the text of the changes, you may view them here. This issue of Quick Notes will focus on these changes. In each table below, you will see the new values to be reported in 2017 on the right.

In order to align the date format with Emergency Department (ED) and Ambulatory Surgery (AS) reporting, alterations were made to all date-related inpatient data elements for file transmissions. This changes how dates will be reported for Date of Birth, Admission Date, Discharge Date, and the dates reported with Principal and Other Procedures when submitting a file to MIRCal.

The data element of Sex was also aligned with ED and AS data values. The option of "Other" was removed, and the values to be reported changed from numerical to alphabetic.

More significant changes were made to the Source of Admission and Type of Admission data elements. One significant change is that Source of Admission will no longer be a three-digit code. Source of Admission will consist of the "Point of Origin" and "Route." "Licensure of Site" will no longer be collected in 2017 because the new Point of Origin categories will already reflect this information. Definitions for these data elements are included in the UB-04 Data Specification Manual.

Source of Admission will still occupy spaces 32, 33, and 34 on the file format; however 33 will be reported as a space with no data. You can view this and all other changes in the Format and File Specifications for Inpatient Data.

Unfortunately, many of the old codes cannot be cross-walked to the new 2017 codes as the definitions do not match exactly. Please review the definition changes carefully.
