Correct Reporting of Skilled Nursing Procedures Why your SN/IC records need a closer look

MIRCal analysts frequently receive questions from facilities regarding why their SN/IC (Type of Care 3) data is receiving an edit for not having procedures when they are not typically performed on patients in a skilled nursing bed. In order to answer this question, it is important to note that the type of record a procedure is reported on is closely tied to whether a discharge took place.

A reportable discharge for OSHPD reporting purposes only takes place if a patient:

- 1) is formally released from the hospital
- 2) is transferred to another Type of Care **as defined by OSHPD**
- 3) leaves against medical advice, or
- 4) dies.

Frequently, SN/IC patients are sent to outpatient settings within the facility for procedures. If a SN/IC patient is not discharged to another OSHPD defined type of care within your facility and is sent to any part of the hospital for a procedure that meets OSHPD's definition of a reportable procedure, that procedure must be reported to OSHPD on the SN/IC record. This includes procedures that would not be billed under the SN/IC portion of the patient's stay.

For example, your facility reports a SN/IC patient admitted on 1/3/19 and discharged 2/14/19. On 1/8/19 the patient has complications and is taken to an ambulatory surgery or outpatient room at your facility to have a tracheotomy performed and then returns to SN/IC. The tracheotomy procedure would be reported to OSHPD on the SN/IC record because the patient was not discharged, and the procedure took place during the time of the patient's SN/IC stay.

OSHPD understands that such procedures may be billed separately. However, facilities are required to report such procedures on the SN/IC record to allow data users to see the continuum of care during each inpatient stay.

Along with more significant procedures that are performed in an outpatient setting, there are many instances of reportable procedures that are often performed in a SN/IC setting. A few examples are: debridement (excision or extraction), intubation, and conversion of cardiac rhythms. It is especially important to review SN/IC records of long-term patients for applicable procedures for correct and complete reporting.

Currently, a significant number of facilities appear to be underreporting procedures on their SN/IC records. In the future, MIRCal analysts will be contacting facilities as part of their annual data reviews to confirm correct reporting for SN/IC patients. Please take the time to review your reporting practices and assist your analyst in ensuring the data is accurate. CHIA 2019 We Hope to See You

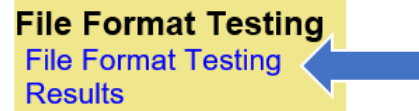

2019 Data Requirements in Effect Submit in July to maximize correction time!

July will be the start of the first Inpatient submission in the new 2019 IP file format when January-June 2019 data is submitted. OSHPD recommends testing your file format and submitting your data file as early as possible. Transmittal errors are very common when there is a file format change so allow ample time to resolve transmittal issues.

The File Format Testing feature is available in MIRCal to check data files for the correct format. This feature does not run the data through any of the other edit programs. The link is found towards the bottom of the MIRCal Main Menu.

2019 Data Reporting Manuals

Updated versions of both Data Reporting Manuals are available as the result of a non-substantive Section 100 regulation package which was approved on May 2, 2019. This package removed obsolete regulatory text, aligned the ZIP Code definition between data types, and added two new Knox-Keene payer plan codes.
