Funding Consideration – Quintiles (Capitation)

- Commission approved methodology
- Twenty programs qualified for funding by receiving at least 50 percent of total points.
- Provides some funding to 10 programs.
- Does not distinguish between ties.
- Program funding amounts:
 - Four programs in quintile one 100 percent of requested funding.
 - Eight programs in quintiles two and three:
 - Five programs receive approximately 75 percent of requested funding.
 - One program receives 30 percent of requested funding.
 - Two programs are not funded.
- Total capitation funding allocation: \$1,736,000 (\$1,006,513 left for special programs funding)



Funding Consideration – Quintiles (Special Programs)

- Commission approved methodology
- Twelve programs qualified for funding by receiving at least 50 percent of total points.
- Provides funding to eight programs (100% of requested funds).
- Total special programs funding allocation: \$992,907
- Total quintiles funding allocation:

Funding Consideration – Alternative One (Capitation)

- Twenty programs qualified for funding by receiving at least 50 percent of total points.
- Provides some funding to 13 programs.
- Program funding amounts:
 - Four programs in tier one 100 percent of requested funding.
 - Nine programs in tier two and three 50 percent of requested funding.
- Total capitation funding allocation: \$1,840,000 (\$902,513 left for special programs funding)



Funding Consideration – Alternative One (Special Programs)

- Twelve programs qualified for funding by receiving at least 50 percent of total points.
- Provides funding to seven programs (100% of requested funds).
- Total special programs funding allocation: \$867,907
- Total alternative one funding allocation:

Special Programs	\$867,907
Total	\$2,707,907

• Unallocated funds: \$34,606



Funding Consideration – Alternative Two (Capitation)

- Twenty programs qualified for funding by receiving at least 50 percent of total points.
- Provides some funding to all 20 qualifying programs.
- Program funding amounts:
 - Tier one:
 - Top program receives 100 percent of requested funds.
 - Remaining three programs in tier one receive 80 percent of requested funds.
 - Tier two:
 - Six programs receive 50 percent of requested funding.
 - Tier three:
 - Three programs receive 40 percent of requested funding.
 - Tier four:
 - Seven programs receive 30 percent of requested funding.

Total capitation funding allocation: \$2,108,000 (\$634,513 left for special programs funding)



Funding Consideration – Alternative Two (Special Programs)

- Twelve programs qualified for funding by receiving at least 50 percent of total points.
- Provides funding to five programs (100% of requested funds).
- Total special programs funding allocation: \$619,009
- Total alternative two funding allocation:

Capitation	\$2,108,000
Special Programs	\$619,009
Total	\$2,727,009
