# What is an IOR?

Inspector of Records (IORs) are independent hospital inspectors who are certified by OSHPD's Facilities Development Division (FDD). Their job is to provide competent, adequate and continuous inspection of all phases of the hospital construction process to assure that the work is being done in accordance with OSHPD approved plans and applicable codes.





7-144 Inspection

The general duties of the inspector shall be as follows:

 The inspector shall have personal knowledge, obtained by competent, adequate and continuous inspection of all parts of the work of construction in all stages of its progress to ensure that the work is in accordance with the approved construction documents.





### **Continuous inspection**

 Continuous inspection means complete inspection of every part of the work. Work, such as concrete or masonry work which can be inspected only as it is placed or assembled, shall require the constant presence of the inspector. Other types of work which can be completely inspected after the work is installed may be carried on while the inspector is not present. In no case shall the inspector have or assume any duties which will prevent continuous inspection.



 The inspector shall work under the direction of the architect or engineer in responsible charge. All inconsistencies or seeming errors in the approved construction documents shall be reported promptly to the architect or engineer in responsible charge for interpretation and instructions. In no case, however, shall the instructions of the architect or engineer in responsible charge be construed to cause work to be done which is not in conformity with the approved construction documents.



• The inspector shall maintain a file of approved construction documents on the job at all times including all reports of tests and inspections required by the construction documents and shall immediately return any unapproved documents to the architect or engineer in responsible charge for proper action. The inspector shall also maintain on the job at all times, all codes and regulations referred to in the approved construction documents.



- The inspector shall notify the Office:
- When the work is started or resumed on the project.
- At least 48 hours in advance of the time when foundation trenches will be complete, ready for footing forms.
- At least 48 hours in advance of the first placing of concrete.
- When work has been suspended for a period of more than two weeks.



 All field records of construction progress shall be retained on the job until the completion of the work and shall, upon request, be made available to the Office, the architect or engineer in responsible charge and the owner. Upon completion of the project, these original field records shall be submitted to the hospital governing board or authority.





The inspector shall notify the contractor, in writing, of any deviations from the approved construction documents or new construction not in compliance with the *California Building Standards Code*, which have not been immediately corrected by the contractor. Copies of such notice shall be forwarded immediately to the architect or engineer in responsible charge, owner and to the Office.





# What are the IOR's allowed to inspect?

The differences between A, B, and C certifications:

Class "A" Hospital Inspector may inspect all areas of construction, including: architectural, mechanical, plumbing, electrical, fire and life safety, and structural elements.

Class "B" Hospital Inspector may inspect only the following areas of construction: architectural, mechanical, plumbing, electrical, fire and life safety, and anchorage of nonstructural elements.

Class "C" Hospital Inspector may inspect one or more areas of construction specialty, including but not limited to the areas listed in Section 7-204(c)I, but may not inspect the complete scope of construction authorized for "A" or "B" inspectors.



### 7-204 Minimum qualification for examination

An applicant must meet the following criteria to be eligible to participate in the certification examination for a Class "A," "B," or "C" Hospital Inspector:





### **Class "A" Hospital Inspector Exam**

High school graduation or the equivalent,

### **AND**

- Six(6) years experience involving building projects of Type I or II construction as an architect's, engineer's, owner's, local building official's or general contractor's representative in technical inspection or inspection supervision
  - [Note: Experience in subsection (a) 1 may be substituted with college education with major work in architecture, engineering, building inspection and/or construction on a year-for-year basis for a maximum of two years.];



### Class "A" Hospital Inspector Exam

• Possess a valid California registration/license as a mechanical, electrical, or civil engineer

### **AND**

 two (2) years experience involving building projects of Type I or II construction as an architect's, engineer's, owner's, local building official's or general contractor's representative in technical inspection or inspection supervision; or



### Class "A" Hospital Inspector Exam

 Two(2) years of working experience as a Class "B" Hospital Inspector;

### OR

 Possess a valid California registration/license as a structural engineer or a valid California license as an architect.



### Class "B" Hospital Inspector Exam

High school graduation or the equivalent,

### **AND**

- Four(4) years experience involving building projects of Type I or II construction as an architect's, engineer's, owner's, local building official's or general contractor's representative in technical inspection or inspection supervision
  - [Note: Experience in subsection (a) 1 may be substituted with college education with major work in architecture, engineering, building inspection and/or construction on a year-for-year basis for a maximum of two years.];



### **Class "B" Hospital Inspector Exam:**

Possess a valid California registration/license as a civil engineer

### **AND**

 two (2) years experience involving building projects of Type I or II construction as an architect's, engineer's, owner's, local building official's or general contractor's representative in technical inspection of more than one major structural or nonstrucal system of buildings (structural, mechanical, electrical or plumbing);



### Class "B" Hospital Inspector Exam

 Possess a valid California registration/license as a structural, mechanical or electrical engineer or a valid California license as an architect;

- Possess a valid certification in all of the following four categories
  - ICC certification as a California Commercial Building Inspector,
  - ICC certification as a California Commercial Electrical Inspector,
  - IAPMO certification as a California Plumbing Inspector,
  - IAPMO certification as a California Mechanical Inspector



### Class "C" Hospital Inspector Exam

High school graduation or the equivalent,

### AND

- Four (4) years experience four years experience involving commercial or institutional building projects as the representative in testing, inspection or observation of construction for an architect, engineer, owner, local building official, local fire authority, testing lab, specialty contractor or general contractor and must possess valid certification issued by an organization specified in 4 below.
  - [Note: Experience in subsection (a) 1 may be substituted with college education with major work in architecture, engineering, building inspection and/or construction on a year-for-year basis for a maximum of two years.];



### Class "C" Hospital Inspector Exam

Possess a valid California registration/license engineer;

### **AND**

 Two (2) years experience involving building projects as an architect's, engineer's, owner's, local building official's, local fire authority's, specialty contractor's or general contractor's representative in testing inspection or observation of construction

### **AND**

• must posess at least one valid certificate issued by an organization that is listed or described in (4)





## Class "C" Hospital Inspector Exam

 Possess a valid California registration/license as a civil, mechanical or electrical engineer or a valid California license as an architect;

### **AND**

Must possess at least one valid certificate issued by an organization specified in (4)



# Class "C" Hospital Inspector Exam 11 Specialties

- Accessibility Division of the State Architect Certification as a Certified Access Specialist (CASp)
- Anchorage/Bracing of Nonstructural Components Certification to be administered by the Office
- Electrical International Code Council (ICC) certification as a California Commercial Electrical Inspector (I2)

- Meet the Minimum Qualifications for the exam.
- Use the application currently posted on our website.
- Attach required supporting documents.
- Send application to correct OSHPD address.
- Include an Application Review Fee of \$100.00 via cashier's check/money order. (On-line payments N/A.)

### Class "C" Hospital Inspector

May inspect on or more areas of construction specialty, including but not limited to the areas listed in Section 7-204(c). A Class C Hospital Inspector may not inspect complete scope of construction authorized for Class "A" or "B" inspectors.

### Qualification Method 1

High school graduation or the equivalent and four years' experience involving commercial or institutional building projects as the representative in testing, inspection or observation of construction for an architect. engineer, owner, local building official, local fire authority, testing lab, specialty contractor or general contractor and must possess valid certification issued by an organization specified in the California Administrative Code Title 24, Part 1, Article 19, Section 7-204(c). [Note: Experience in subsection (c)(1) may be substituted with college education with major work in architecture, engineering, building inspection and/or construction on a year-foryear basis for a maximum of two years.];



# Required Documentation

- A completed application make sure the application is signed, all job experience dates are accurate, project name and construction costs are included.
- High School Diploma or Equivalent.
- Certificates or transcripts indicating educational courses completed which relate to the minimum qualifying requirements.
- Work verification letter written and signed by <u>a recognized</u> representative from a present and/or past employer regarding any job which meets the minimum qualifications must include the applicant's name, dates of employment, duties performed, and employer's phone number.



# Reasons an Application is Denied

- Application improperly completed.
- Missing documentation, e.g., high school diploma, work verification letter, certificates.
- Submitted false information. (We verify work experience.)
- Not enough years of experience.
- Didn't submit \$100.00 "Application Fee" via cashier's check or money order.



# **IOR Re-Certification**

- 7-211 Renewal of a hospital inspector certificate
- A Hospital Inspector shall participate in a recertification seminar and written exam within the three-year certification period. Prior to the expiration of the certification in order to renew and maintain valid certification.
- Submit a recertification exam fee of \$100 via cashier's check or money order.



# **IOR Re-Certification**

7-202 Filing change of name, address or telephone number

An applicant for the certification examination or a Hospital Inspector possessing a valid certificate issued by the Office, shall file name, mailing address or telephone number changes with the Office in Sacramento within 10 working days of that change. The information filed shall include both the new and former name, mailing address or telephone number.
