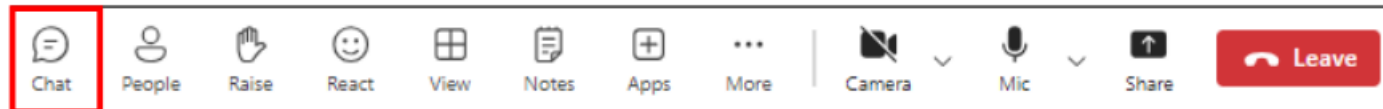

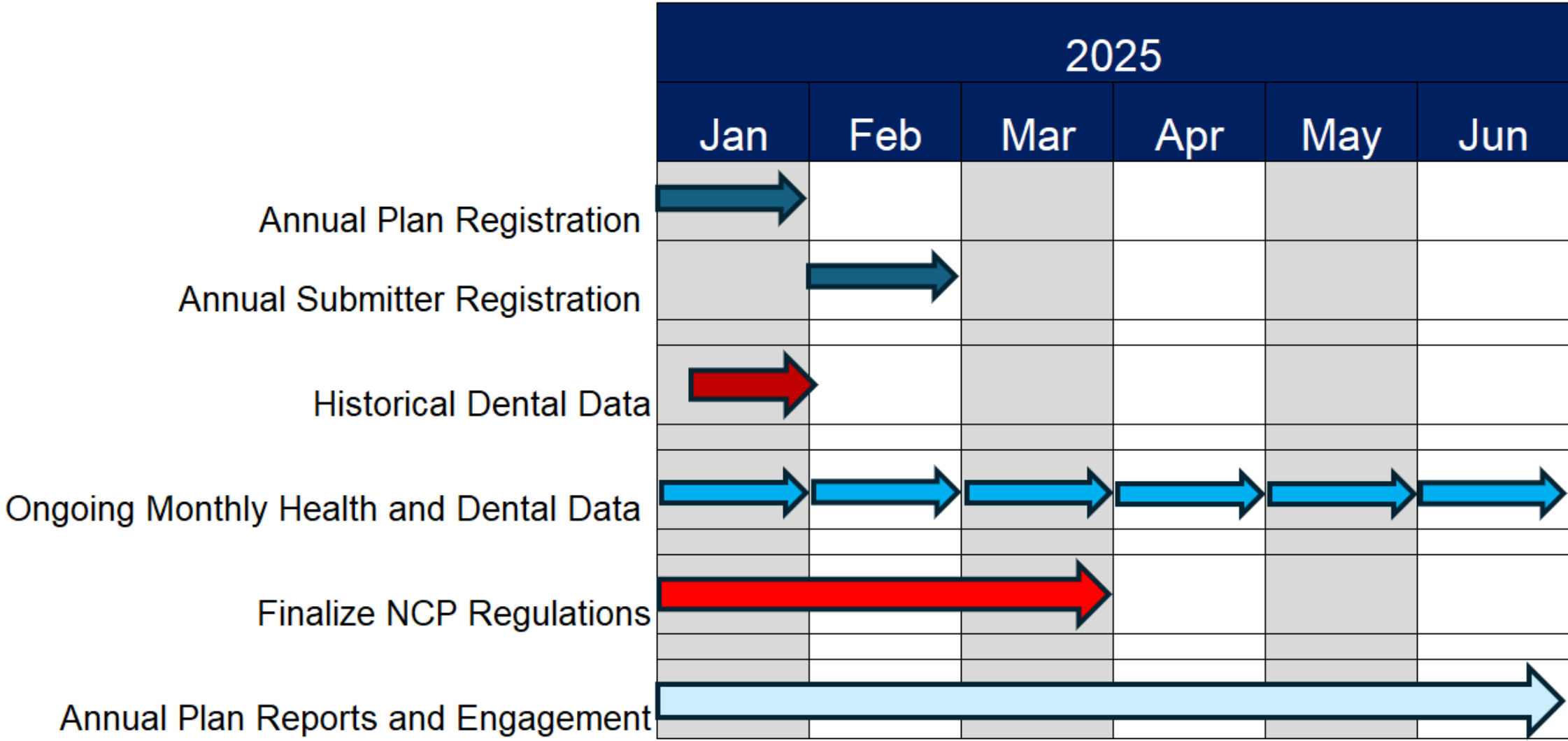

HPD Key Deadlines

- Plan registration will take place during the month of January and by the last calendar day of January 2025.
- Submitter registration will take place each year after plan registration has been completed and by the last calendar day of February 2025.
- Dental Data for January 2022 – October 2024 due 02/03/2025
- Monthly data for December 2024 data due 02/03/2025

Data Collection Regulations Reminder

- HPD data collection regulations were certified on November 17, 2023
 - [California Code of Regulations Sections 97300-97370](#)
- Regulations will need to be updated with additions of new data collection requirements and/or for each biennial release of the All-Payer Claims Database-Common Data Layout (APCD-CDL)

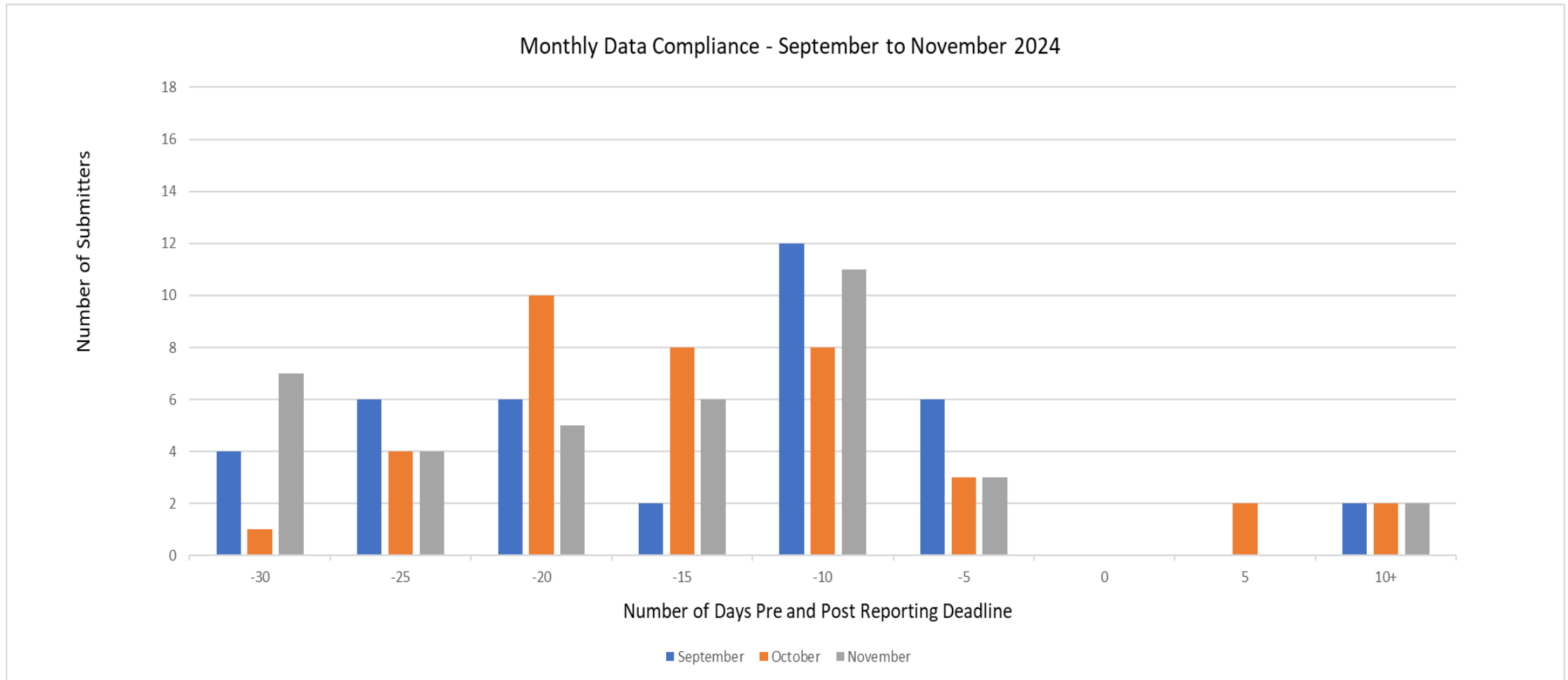

 - November (01/02/2025) - 36 of 38 submitters

Overview of HPD Registration

- Required as part of [California Code of Regulations Sections 97330-97334](#)
- Registration helps us identify...
 - Key plan and submitter contacts
 - TPA, PBM, and carve-out relationships
 - Product offerings and other attributes of each registered plan
- Beginning in 2025, registration includes information on Non-Claims Payment (NCP) file types

Plan and Submitter Registration

- Two different types of registration are required via the HPD portal: one for plans and one for submitters
- Outlined in the [HPD Data Submission Guide 2.0](#)

2.1 Plan Registration

This includes any mandatory submitter, such as a health plan, insurer or public self-insured entity, and any voluntary submitter (directly or through an authorized agent of the voluntary submitter). For licensed entities such as health plans or insurers, the registration is at the license level.

2.2 Submitter Registration

Each entity who will submit data to HPD must register via the data portal. Plans who will submit data themselves (without any delegation) must also register as a submitter.

Plan & Submitter Registration

- Plan registration must be approved before submitter registration can begin
- Plans will receive confirmation of registration approval from Onpoint
- Coordinate with the submitter(s) that will report eligibility, medical claims, pharmacy claims, dental claims, provider files, and/or NCP files on your behalf
- If an entity serves as both a plan and a submitter, submitter registration is also required
- Submitter registration should be completed by February 28, 2025

Three New File Types for Plan & Submitter Registration

- Beginning in 2025, the registration process will include 3 new file types for collection of non-claims payment (NCP) data:
 - Annual Payments
 - Pharmacy Rebates
 - Capitation

Option for Early Non-Claims Payment Registration

January - February 2025 Registration Period

- Plans have the option to:
 - Identify the submitter(s) who will be sending their non-claims payment (NCP) files
 - Provide contacts for NCP file types
- Submitters have the option to:
 - Identify the plan(s) on whose behalf they will be sending NCP file types
 - Provide contacts for NCP file types

Option for Early Non-Claims Payment Registration

- If your organization will not be submitting any of the NCP file types, or you do not know if your organization will be submitting NCP data files, please select...
 - Plans – “This data file type is not submitted by our organization”
 - Submitters – “Not Applicable”
- Plans and submitters will have another opportunity to update their registration for NCP file submission later in the year
- Check email settings to ensure receipt of Onpoint and HCAI reminders
 - Onpoint will be sending email reminders when it’s time to edit plan and submitter registrations to update NCP file submission information
