#### **Executive Summary**

The Office of Statewide Health Planning and Development's (OSHPD) Health Professions Education Foundation (HPEF) is a nonprofit 501(c)(3) foundation that improves access to health care in underserved areas of California by providing scholarships and loan repayments to health professional students and graduates who provide direct patient care in those communities. Health and Safety Code Section 128557(a) requires HPEF to submit a report to the Legislature documenting the performance of the Steven M. Thompson Physician Corps Loan Repayment Program (STLRP).

The report must include: 1) the number of STLRP program participants, 2) name and location of all practice settings with program participants, 3) amount expended for the program, 4) annual performance reviews by the practice settings, and 5) the program participants and the status of the Physician Volunteer Program. This report does not include an update on the Physician Volunteer Program as HPEF does not currently administer this program.

This report covers the three-year period from July 1, 2016 through June 30, 2019.

During the report period, HPEF administered three application cycles. Available program funding determined total awards.

For Fiscal Year (FY) 2016-17 through FY 2018-19, Table 1 details the total number of applications received, the number of awards, the total dollar amount awarded, and the award start date for each cycle.

#### **Program Authority**

STLRP is authorized by Health and Safety Code, Sections 128550-128558 and the California Code of Regulations, Title 22, Section 97931.01-97931.06. Since July 2006, HPEF has administered STLRP. Previously the Medical Board of California administered the program.

#### **Program Funding**

For the report period, HPEF received funding from:

- Medical Board of California and Osteopathic Medical Board of California licensure fees
- Managed Care Administrative Fines and Penalties Fund, administered by the Department of Managed Health Care.
- The California Endowment (TCE), a one-time \$21.4 million grant.<sup>1</sup>

<sup>&</sup>lt;sup>1</sup> Of the \$21.4 million TCE grant award, in 2014 the first-year allocation was \$9.7 million; the second year was \$6.2 million; and the third year was \$5.5 million. TCE authorized HPEF to redirect any unspent funding to a fourth and final year.

#### **Program Background**

STLRP was established in 2003 to increase access to health care and promote the retention of primary care physicians in medically underserved areas² (MUAs) of California. An advisory committee of seven members counsels the program. The California Medical Association appoints two of the seven advisory committee members. HPEF, in consultation with the Medical Board and OSHPD, appoints the remaining five members, which may include other members of the medical community.

Since the program's inception in 2003, STLRP has received 2,311 applications, awarded more than \$61 million to 765 recipients providing direct patient care, and monitored awardees' compliance with the three-year service obligation in a qualifying practice setting. Approximately 80 percent of all recipients are primary care providers. Physicians and surgeons can receive up to \$105,000 in exchange for providing direct patient care in a MUA for a minimum of three years.

All recipients must serve in a MUA, and a practice setting where more than 50 percent of patients are uninsured, Medi-Cal beneficiaries, or beneficiaries of another publicly funded program serving patients who earn less than 250 percent of the federal poverty level.

Awardees must work in an eligible facility designation, which includes:

- Federally designated Health Professional Shortage Area (HPSA) areas deficient in primary care or mental health providers,
- Primary Care Shortage Area (PCSA) areas with shortages of family physicians, as determined by the California Healthcare Workforce Policy Commission,
- Federally Qualified Health Centers (FQHC),
- Rural health centers, county, veterans, and other community clinics.

#### **STLRP Selection Committee**

Health and Safety Code Section 128553(d)(1) establishes a STLRP selection committee. The Committee must have a minimum of three members, including a member appointed by the Medical Board of California. HPEF appoints the remaining two members from the medical community or members of the public with expertise in healthcare issues.

The selection committee must award at least 65 percent of available funds to primary care physicians who have completed a postgraduate residency in the areas of family practice, internal medicine, pediatrics, or obstetrics and gynecology. The selection committee may award up to 15 percent of the total funds to physicians and surgeons who practice in geriatric care settings, and up to 20 percent of funds to physicians in non-primary care specialties.

The STLRP selection committee determines whether the applicant meets the cultural and linguistic needs of patients and gives applicants priority consideration based on meeting one or more of the following criteria:

- Speaks a Medi-Cal threshold language.
- Comes from an economically disadvantaged background.
- Has significant training in culturally and linguistically appropriate service delivery.

<sup>&</sup>lt;sup>2</sup> "Medically underserved area" is an area defined as a health professional shortage area in Part 5 of Subchapter A of Chapter 1 of Title 42 of the Code of Federal Regulations, or an area of the state where unmet priority needs for physicians exist as determined by the California Healthcare Workforce Policy Commission pursuant to Health and Safety Code Section 128225.

- Has three years of experience working in a medically underserved area or with a medically underserved population.
- Has obtained a license to practice medicine in the United States or Canada within the last 15 years.

The STLRP selection committee also considers where an applicant works to ensure a geographic distribution of awards.

#### **Section 1: Participants and Awards**

Table 2 below details the eligibility results from each application cycle for FY 2016-17 through FY 2018-19.

In FY 2017-18 and FY 2018-19, the total number of awards decreased by more than 50 percent compared with FY 2016-17 because of reduced funding. For the application cycle starting on FY 2019-20, HPEF created an eligibility quiz intended to reduce the number of ineligible applications that do not meet the practice setting or full-time requirements.

Table 3 details practice specialty. While awards to both family physicians and other specialties decreased in FY 2018-19, awards to the remaining specialties increased from FY 2017-18. Over the past three fiscal years, HPEF has not received any applications from gerontologists.

#### **Section 2: Practice Settings**

Appendices A-F detail the distribution of recipients by practice setting, employment county, shortage designation, and award amount.

In FY 2016-17, HPEF used TCE grant funding to award 42 primary care physicians providing direct patient care in Alameda, Contra Costa, Del Norte, Fresno, Kern, Los Angeles, Madera, Monterey, Orange, Riverside, Sacramento, San Diego, and Tulare counties.

In FY 2017-18, HPEF awarded the remaining TCE grant funding to two family practice physicians in Orange and Fresno Counties and one pediatrician in Los Angeles County.

#### **Section 3: Expenditures**

Total expenditures for the report period are \$15.1 million. STLRP awards for this report period include an annual allocation from the Medical Board of California and the Osteopathic Medical Board of California through a \$25 licensure fee surcharge, an annual allocation of \$1 million from the Managed Care Administrative Fines and Penalties Fund, and remaining grant funding from TCE.

#### **Section 4: Performance**

HPEF continues to monitor 264 active STLRP awardees from previous cycles for statutory and regulatory guidelines compliance. Each recipient is contractually obligated to work full-time providing direct patient care for a minimum of three years in a MUA. Every six months, HPEF requests a signed statement from the recipient's employer or practice site to verify employment and eligibility for continued program participation and award payments.

As an awardee completes each year of service, HPEF issues a portion of the total award for the repayment of their educational debt: 24, 33, and 43 percent of the total award each year.

When the awardee completes their service obligation, HPEF sends a post-program survey to evaluate the program effectiveness. HPEF evaluates the survey data to improve future outreach, application, and award processes.

#### Appendix B: FY 2016-17 Map of Recipients by Employment County



#### Appendix D: FY 2017-18 Map of Recipients by Employment County


