Substance Use Disorder (SUD) Earn and Learn (E & L) Grant Program: Purpose

- Expand and train the SUD Workforce
- Increase the number of certified SUD counselors
- Pay students during their required education and field practicum hours
- Recruit culturally and linguistically diverse SUD students representing the socio-demographic needs of the communities they serve

SUD E & L Grant Program: Eligible Applicants

HCAI will accept applications from:

- Public and Private Universities
- Public and Private Colleges
- Teaching Facilities (Online or In-person)
- Other Types of SUD Training Programs

SUD E & L Grant Program: Applicant Requirements

Applicants must be able to:

- Report the quantitative measures of SUD needs in their region
- Report partner educational institution(s) and/or training organization(s)
- Provide oversight of workforce training that prepares SUD professionals to sit for their IC & RC Exams
- Demonstrate experience training and supporting individuals working in the SUD profession
- Have their SUD E & L Program in place within twelve months from the contract execution date

*A group of organizations meeting the criteria above may apply, with one organization identified as the fiscal sponsor

SUD E & L Grant Program: Funding

2-3 awards will be granted, each with a maximum of \$7.75 million dollars to support:

- Creating/expanding an earn and learn program for SUD certification students
- Paid internship/field practicum, paid time on schooling activities, covering costs of certification fees
- Incentive programs for educational instructors and SUD experience mentors
- Externship "Work Experience" placement bonuses

SUD E & L Grant Program: Awards

- **Award Levels:** HCAI may award full, partial, or no funding to an applicant based on the applicant's success in meeting the selection criteria and the amount of funds available
- **Geographic Distribution:** Award decisions will be based on the applicant's selection criteria score and geographical coverage across California

SUD E & L Grant Program: Budget

- HCAI will make a payment equal to 20 percent of the grant upon execution of the grant agreement
- Arrears Payments: Remaining grant funds will be awarded quarterly in “arrears,” as expenses are incurred
- Administrative/Indirect costs: Up to 15% of grant funds may be used for administrative costs
- Non-Supplantation: Grantees may not use HCAI funds to supplant funds the grantee has received from another source for the same purpose

SUD E & L Grant Program: Program Components

The E & L Grant Program is three years and will provide:

- IC & RC exam costs
- SUD internship "Field Practicum" hours
- AOD specific education hours
- Mentor and Educator financial incentives
- Placement bonuses

SUD E & L Grant Program: Program Component Amounts

Program Category	Funding Amount
Student Compensation	\$20,000 per student
Mentor Training Incentives	Up to \$10,916 per student
Educator Incentives	Up to \$8,145 per student
SUD Exam and Certification Fees	\$350 per student
Placement Bonus (Optional)	Up to 5% of total direct cost
Indirect Costs	Shall not exceed 15% of Total Direct Cost

SUD E & L Grant Program: Program Provisions

- Provide students with a stipend to pay them while they complete their required education and field practicum hours in order to sit for their IC & RC Exam.
- **Optional:** Grantee may choose to participate in the placement component, which comprises placing students in a paid SUD position where they can attain the remainder of their work experience hours after passing their IC & RC exam. Grantee will be awarded an additional five percent of the direct program cost

SUD E & L Grant Program: Budget Example

An organization was awarded \$1,000,000 in funding

- Upon contract execution, the organization will receive a payment of \$200,000 to begin its program
- The remainder of their award, \$800,000, will be awarded in arrears quarterly after HCAI receives the organization's quarterly report for services
- Up to \$150,000 of the \$1,000,000 awarded can be used toward administrative and indirect costs
- The \$1,000,000 award may not be used to supplement any other program for which funding was received from another source for the same purposes

SUD E & L Grant Program: Grant Timeline

- Grant Agreement Start Date: June 2023
- Report deliverables quarterly and annually through fiscal year 2025-26

SUD E & L Grant Program: Key Application Information (1/2)

- Number of staff who speak Medi-Cal threshold languages proficiently while practicing in a program setting
- Number and location of training sites
- Strategies to recruit and support students from underrepresented communities
- Strategies to encourage students to practice in areas of unmet need
- Strategies to implement culturally responsive care training into the program's curriculum

SUD E & L Grant Program: Key Application Information (2/2)

- Strategies to train students to support children/youth with SUD behavioral health services
- Strategies to ensure the students in your program will receive offers for full-time employment after completing the program and student placement
- Resources for promoting student success
- Strategies for recruiting SUD counselors with lived SUD experience
- Proposed budget

SUD E & L Grant Program: Scoring Criteria (1/2)

- Medi-Cal threshold languages spoken by staff
- SUD prevalence score at training locations
- Strategies to train students to support children/youth with SUD behavioral health services
- Resources to promote student success
- Strategies to recruit students from underrepresented communities

SUD E & L Grant Program: Scoring Criteria (2/2)

- Strategies to encourage students to practice in areas of unmet need
- Strategies to implement culturally responsive care into program's curriculum
- Strategies to ensure students receive offers for full-time employment after program completion AND placement component for finding paid employment positions after program completion
- Strategies for recruiting SUD counselors with lived experience

SUD E & L Grant Program: Annual Program Reports

- Required to receive ongoing funding
- Due July 31 after each fiscal year (July 1-June 30)
- Reports include:
 - Numbers and sociodemographic characteristics of students
 - Program information
 - Expenditures and changes in annual budget within total grant amount awarded
- HCAI will send grantees an online form annually for reporting the required information

SUD E & L Grant Program: Quarterly Reports

- Required to receive ongoing funding
- Reports include:
 - Number of students served
 - Number of students who have taken the examination
 - Number of students who completed the program by successfully completing the required
 - Alcohol and Other Drug specific education hours, field practicum hours, and passing the IC&RC examination
- HCAI will send grantees an online form quarterly for reporting the required information
