1 Capitation Funding: Capitation funding supports the education and training of one full-time resident or student. Capitation funding is available for all disciplines funded by the Song-Brown Program. Per resident/student capitation rates vary based on the discipline applying for funding.

2 Registered Nurse: A RN is a nurse who successfully completes a program meeting Board of Registered Nursing standards as specified in the California Nursing Practice Act. The practice of nursing as defined by Section 2725 of the California Nursing Practice Act means those functions, including basic health care, that help people cope with difficulties in daily living that are associated with their actual or potential health or illness problems or the treatment thereof, and that require a substantial amount of scientific knowledge or technical skill.
