EDUCATION AND TRAINING PROGRAMS

- [Psychiatric/Social Worker Education Capacity Expansion](#) (PECE/SWECE) Grant Program
 - Funds new psychiatry residency programs, new child/adolescent psychiatry fellowships, new addiction fellowships, and the expansion of existing psychiatry, child/adolescent, and addiction fellowships.
 - Funds new programs and expansion of PMHNPs training programs.
 - Funds additional residency slots for Addiction Psychiatry and Addiction Medicine fellowship programs. *(In progress)*.
 - Funds new and expanding programs training social work students. *(In progress)*
- [Peer Personnel Training and Placement](#)
 - Provides funding to organizations for the training and certification of peer support specialists and supports the facilitation of placements of peer personnel.
- [Train New Trainers Primary Care Psychiatry Fellowship](#)
 - Provides funding to train primary care physicians, family practice nurse practitioners, and physician assistants in primary care psychiatry.
- Behavioral Health Coach Workforce
 - Develop and implement behavioral health coach role to increase access for children and youth in school and community settings. *(In progress)*
- Train New Trainers Primary Care Addiction Medicine Fellowship
 - Provides funding to train primary care physicians, family practice nurse practitioners, and physician assistants in addiction medicine. *(In progress)*
- Community Health Worker Initiative
 - Provides for the recruitment, training, and certification of community health workers with specialized training to work with populations such as justice-involved, people who are unhoused, older adults and people with disabilities. *(In progress)*
- Licensed Behavioral Health Professional Initiative
 - Funds the increase of licensed behavioral health professionals through grants to university or college behavioral health professional training programs. *(In progress)*
- Golden State Social Opportunities Program
 - Provide grants to students in postgraduate behavioral health programs. *(In progress)*
- Substance Use Disorder (SUD) Workforce
 - Funds the increase of SUD counselors and licensed SUD providers. *(In progress)*
- Earn and Learn Apprenticeship Program
 - Funds earn and learn models that build the behavioral health workforce. *(In progress)*
- Enhancing Training to Serve Justice and System-Involved Youth
 - Funds training programs that enhance the skills and knowledge of new and existing staff involved in juvenile justice and system-involved youth. *(In progress)*

RECRUITMENT AND RETENTION PROGRAMS

Loan Repayment Programs

- Allied Healthcare Loan Repayment Program
 - Includes social workers, marriage and family therapists, substance use disorder (SUD) counselors, licensed professional clinical counselors, and psychologists.
- Bachelor of Science Nursing Loan Repayment Program
 - Includes psychiatric nurses.
- California State Loan Repayment Program
 - Includes psychiatrists, PMHNPs, social workers, marriage and family therapists, licensed professional clinical counselors, psychologists, and SUD counselors.
- Licensed Mental Health Services Provider Education Program
 - Includes all behavioral health providers that are licensed or have a certification.
- Steven M. Thompson Physician Corps Loan Repayment Programs
 - Includes psychiatrists.

Scholarships

- Allied Healthcare Scholarship Program
 - Includes social workers, marriage and family therapists, SUD counselors, psychiatric technician, and psychiatric aid.
- Associate Degree Nursing Scholarship Program
 - Includes students that may pursue nursing careers in behavioral health settings.
- Bachelor of Science Nursing Scholarship Program
 - Includes students that may pursue careers in behavioral health settings.
- Advanced Practice Healthcare Scholarship Program
 - Includes PMHNP and psychiatric nursing students.
- Stipends
 - Establish stipends for social work students. *(In progress)*

PIPELINE PROGRAMS

- Health Professions Pathways Program
 - Provides funding to organizations that will develop and implement health professions pathways programs that can include pipeline programs, summer internships, and post undergraduate fellowships with a focus on programs designed to recruit and support students from underrepresented regions and backgrounds.
- Health Careers Exploration Program
 - Provides funding to organizations to strengthen educational and social foundations by providing direct and indirect program support for underrepresented and/or disadvantaged individuals interested in pursuing healthcare careers.
- Culturally Diverse Future Behavioral Health Workers
 - Establishes program to attract and support high school students considering professional careers in behavioral health. *(In progress)*
