



Allied Healthcare Loan Repayment Program (AHLRP) for the County Medical Services Program (CMSP)

This program is funded by the County Medical Services Program (CMSP). Eligible applicants may receive loan repayments of up to \$16,000 in exchange for a 12-month service obligation practicing direct patient care at one of the CMSP-contracted provider sites in any of the 35 CMSP-designated Counties*.

The application cycle will be open May 8, 2023, at 3:00 p.m. – July 31, 2023, at 3:00 p.m. To apply, visit https://funding.hcai.ca.gov/.

The Department of Health Care Access & Information (HCAI) is only awarding Allied Healthcare Professionals in CMSP-designated counties, practice sites, and disciplines. To be eligible for AHLRP, an applicant must be currently licensed and practicing one of the following Allied Healthcare disciplines:

In addition, applicants must:

- Be in good standing with their respective licensure, board, or certification
- Not have any other existing service obligations with other entities, including other HCAI programs
- Not be in breach of any other health professional service obligation
- Have unpaid educational loans
- Commit to providing a 12-month service obligation at a CMSP-contracted provider site
- Be providing 32-hours or more per week of direct patient care
