

## **Health Care Workers Minimum Wage**

Senate Bill 525 (Chapter 890, Statutes of 2023) establishes a \$25 health care employee minimum wage, with four different phase-in schedules for employers based on various characteristics. The Department of Health Care Access and Information (HCAI) has a role in posting information about specified health care facility employers to its internet website. (Labor Code, § 1182.14, subd. (h).)

HCAI does not oversee, enforce, or control the phase-in schedule for employers. Information about the phase-in schedule is available in Labor Code Section 1182.14, subdivision (c) and Labor Code Section 1182.15, subdivision (c).
